

Labour Relations Board

The Labour Relations Board was created in 1944 with the passage of *The Trade Union Act*, S.S. 1944 (2nd Sess.) c. 69. Although the Act has often been amended, most recently in 2008, the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under *The Trade Union Act*. It does this principally through public hearings and written decisions.

The Board's decisions are final and binding upon the parties. There is no appeal, and review by the courts is strictly limited.

The Act presently provides for a board comprised of a chairperson and up to two vice-chairpersons and an unspecified number of members. All members of the Board, including the chairperson and vice-chairperson, are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational Board. This means that all members of the Board, with the exception of the chairperson and vice-chairperson, are representatives of employees or employers. The chairperson and vicechairperson are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety, for the Province of Saskatchewan. The Minister is obligated by *The Trade Union Act* to provide the Board with the requisite staff and facilities. The Board operates independently from the government, its departments and agencies. The chairperson, vice-chairperson and all members of the Board are required by the Act to take an oath of impartiality in the performance of their office.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is comprised of the Board Registrar, Senior Industrial Relations Officer/Investigating Officer, Executive Assistant to the Chairperson and two clerical positions. The chairperson or the vice-chairperson is appointed to act as Executive Officer of the Board. An Organizational Chart of the Labour Relations Board is contained in Appendix 1.

The composition of the Board for 2012-2013 was:

Kenneth G. Love, Q.C. – Chairperson

Kenneth G. Love Q.C., was appointed as Chairperson and Executive Officer of the Saskatchewan Labour Relations Board in March 2008. He was reappointed to those positions for a further five year term in March 2013.

Prior to his appointment to the Labour Relations Board, Mr. Love was in private practice in the City of Regina. He was named a Queen's Counsel in 1989 and was the recipient of the Canada 125 medal in 1992.

Mr. Love obtained his Juris Doctor degree (formerly an LLB) and a Bachelor of Arts degree from the University of Saskatchewan.

Steven Schiefner – Vice-Chairperson

Steven Schiefner was appointed Vice-Chairperson of the board in August 2008. Mr. Schiefner obtained his law degree from the University of Saskatchewan and has been a practicing solicitor since 1994. Prior to that, Mr. Schiefner attended the Alberta College of Arts in Calgary, Alberta, where he studied Commercial and Fine Art, and the University of Regina, where he studied Business Administration and completed his pre-law requirements. Prior to his appointment to the Board, Mr. Schiefner was the City Solicitor for the City of Moose Jaw, a position he had held for over 11 years.

Gloria Cymbalisty

Gloria Cymbalisty was appointed to the Board in March 1992 as a member representing employees. Ms. Cymbalisty is self-employed as an industrial relations consultant. She was formerly a representative for the Saskatchewan Joint Board, Retail, Wholesale and Department Store Union.

Brenda Cuthbert

Brenda Cuthbert was appointed to the Board in July 1995 as a member representing employers. Ms. Cuthbert is the Vice President of Human Resources for the Siemens Transportation Group Inc.

Donna Ottenson

Donna Ottenson was appointed to the Board in July 1995 as a member representing employees. A lifetime member of the Saskatchewan Union of Nurses, Ms. Ottenson is a retired Registered Nurse who continues to work part time as an Employment Relations Officer with her union.

Hugh Wagner

Hugh Wagner was appointed to the Board in July 1995 as a member representing employees. Mr. Wagner is the General Secretary of the Grain and General Services Union (GSU), International Longshore and Warehouse Union, Canada (ILWU-Canada). Prior to joining the GSU, Mr. Wagner worked in the service sector, the construction industry, and the provincial civil service in Saskatchewan. Mr. Wagner holds a Bachelor of Arts (Honours) and Masters Degree in Political Science from the University of Saskatchewan (Regina Campus) and the University of Regina. Mr. Wagner is a member of the Board of Directors of the Western Transportation Advisory Council, a past Vice-President of the Saskatchewan Federation of Labour, a member of the Executive Board of the ILWU-Canada, a member of the Board of Directors of the Saskatchewan Labour Market Commission and a member of the Board of Directors of Enterprise Saskatchewan.

Duane Siemens

Duane Siemens was appointed to the Board in 2000 as a member representing employees.

Mr. Siemens is a retired millwright from Erco Worldwide. Mr. Siemens was formerly the president of CEP Local 609, Secretary and Vice-President of the Saskatchewan Federation of Labour, and past President of the Saskatoon & District Labour Council.

Clare Gitzel

Clare Gitzel was appointed to the Board in July 2001 as a member representing employers. Mr. Gitzel was formerly employed with a major mining company as Manager of Human Resources and Northern Affairs. He presently provides consulting services in the human resources and administration fields. Mr. Gitzel has left the Board due to health reasons.

Joan White

Joan White was appointed to the Board in July 2001 as a member representing employers.

Ms. White was employed by the University of Saskatchewan for over 35 years. Ms. White's areas of specialization included human resource management, labour relations, and government relations. In addition, she taught labour relations at the Edwards School of Business (College of Commerce). She is currently enrolled in graduate studies.

Maurice Werezak

Maurice Werezak was appointed to the Board in July 2001 as a member representing employees. Mr. Werezak is a past Vice-President of the Saskatchewan Federation of Labour and is President of United Food and Commercial Workers, Local 248-P. Mr. Werezak is a labour representative on the Employment Insurance Appeal Committee and is employed at Mitchell's Gourmet Foods.

Mike Wainwright

Mike Wainwright was appointed to the Board in July 2002 as a member representing employers. Mr. Wainwright is the owner of Mike Wainwright Labour Relations Consulting. He is also the HR Business Development Director for ISM Information Systems Management Canada Corporation (ISM Canada). Mr. Wainwright has held executive HR positions in the retail and wholesale sectors as well as in the manufacturing sector.

John McCormick

John McCormick was appointed to the Board in July 2002 as a member representing employees. Mr. McCormick retired from his position as Transit Operator with the City of Regina after 31 years of service and is Past President of the Amalgamated Transit Union Local 588, having held the position of President for 18 years. Mr. McCormick is a member of the Regina Civic Pension Board. Mr. McCormick was formerly a ATU Canadian Council Executive Board Member. Mr. McCormick is also the owner of McCormick Labour Solutions.

Ken Ahl

Ken Ahl was appointed to the Board in July 2004 as a member representing employers. Mr. Ahl worked for 34 years for Comstock Canada Ltd. and retired in 2003 as the manager of their Saskatchewan office. He has also been active in the construction industry with the CLR – Construction Labour Relations Association of Saskatchewan Inc. and CODC – Construction Opportunities Development Council Inc.

Shawna Colpitts

Shawna Colpitts was appointed to the Board in August 2007 as a member representing employees. Ms. Colpitts is the current Director of Political Action & Education with SEIUWEST. Prior to this, she was a National Representative for SEIU Canada and was responsible for projects such as provincial collective bargaining for health care providers employed within affiliated Regional Health Authorities and Saskatchewan Association of Health Organizations. Ms. Colpitts initially began her employment with an SEIU Local in 1994 and, since this time, has acted as an advocate for a wide variety of classifications of health care providers, as well as employees within affiliated community based organizations. Ms. Colpitts holds a General Bachelor of Arts and Bachelor of Law degrees and has focused on labour relations throughout her employment and education.

Elma Shoulak

Elma Shoulak was appointed to the Board in August of 2007 as a member representing employers. Ms. Shoulak is the Vice President of Human Resource with Evraz Place. The Trade Union Act

In Canada, legislative jurisdiction over industrial relations has, since a ruling of the Supreme Court of Canada in 1925, fallen largely under provincial jurisdiction. Fortunately, the potential this presented for legal fragmentation was offset by varying combinations of inter-provincial management and union structures, common history and common dayto-day economic and political conditions. The result is a remarkable commonality of core principles and procedures in all 11 Canadian jurisdictions.

The main features of Saskatchewan's *Trade Union Act*, like its counterparts in all other Canadian jurisdictions, may be summarized as follows:

- traditional courts are replaced by a specialized, quasijudicial tribunal with exclusive and binding jurisdiction over the matters assigned to it by *The Trade Union Act*;
- common law of conspiracy and restraint of trade is abolished insofar as it applies to employees who bargain collectively;
- the majority of employees determine for all employees in a group whether they will bargain collectively and, if so, through which union;
- an employer is required to recognize the union chosen by the majority of its employees as their exclusive representative for the purpose of bargaining collectively;
- the employer and the union are required to bargain in good faith with a view to concluding a collective bargaining agreement;
- a number of unfair labour practices are created to protect employees and unions from any attempt by the employer to interfere with their rights;
- strike and lock-out activity is regulated, but not prohibited;
- specific issues, such as union security, technological change, conciliation, voting procedures and religious exclusions are addressed; and
- remedial and enforcement procedures are included in the statute.

In short, the Act provides the legal framework for collective bargaining, along with a procedure for adjudicating disputes and enforcing rights and obligations. *The Trade Union Act*, like its counterparts in all other Canadian jurisdictions, does not attempt to prohibit economic conflict between employees and employers, but only to control it. It does not attempt to regulate the outcome of collective bargaining, but merely the process to be followed.

The function of the Labour Relations Board within this statutory framework is to identify the parties which will participate in collective bargaining, and to monitor the procedural aspects of the bargaining process. Under *The Trade Union Act*, the Board is not required to follow all of

the formal rules of procedure that have been developed in courts of law.

The Board attempts to conduct its hearings in a way that will make them accessible to representatives of the parties who have no legal training, and which will allow the Board to identify the issues which are genuinely in dispute.

The Construction Industry Labour Relations Act, 1992, as amended 2010

Passed in 1992 and amended in 2000, *The Construction Industry Labour Relations Act, 1992*, S.S. 1992, c. C-29.11, provides for a system of collective bargaining in the building trades between organizations representing groups of contractors and the construction unions. The supervision of this statutory system is conferred on the Board under the legislation. On July 1, 2010, amendments to the Act, allowed Unions who were not designated by the Minister pursuant to s. 9 of the Act to make application to the Board under s. 5(a), (b) & (c) of *The Trade Union Act* to represent workers within the construction industry. The amendments allowed a trade union to organize an appropriate unit of employees, which may be a multi-trade, or "all employee" unit, as well as a craft, or single-trade unit.

The Health Labour Relations Reorganization Act

Passed in 1996, *The Health Labour Relations Reorganization Act, S.S. 1996*, c. H-0.03, appointed a commissioner to examine the organization of labour relations between health sector employers and employees in the Province. The Dorsey Commission report was submitted, and *The Health Labour Relations Reorganization (Commissioner) Regulations*, R.R.S., c. H-0.03, Reg. 1 came into force, in January, 1997.

The legislation confers upon the Board the power to make orders for the purpose of carrying out the intent of the legislation and respecting any matter arising out of the reorganization of labour relations in the health care sector not addressed in the Regulations.

The Public Service Essential Services Act

The Public Service Essential Services Act came into force on May 14, 2008. Under that Act, the Board is authorized to determine the number of employees that will be deemed as essential services, in the event that the employer and the trade union representing those employees is unable to reach an Essential Services Agreement which specifies which employees are essential services employees in the event of a work stoppage. The legislation also provides the framework for the parties to amend any Essential Services Agreement, if Board intervention is sought by either party. Rules of practice and procedure may be viewed on the Board's website, <u>www.sasklabourrelationsboard.com</u>.

Budget Summary

The total budget of the Saskatchewan Labour Relations Board for the fiscal year ending March 31, 2013 was \$1,002,000. The actual sum expended by the Board during the fiscal year was \$875,928 representing an underexpenditure of 12.5 per cent as compared to budget. The Board continues to display competence in its ability to manage resources efficiently. Given the reality that the Board is unable to control or predict the nature or number of applications put before it, the relationship of expenditure to budgetary allocation cannot be guaranteed from year to year, but is closely monitored. The Board has now fully integrated its records management system allowing for further capacity with little additional costs in regard to processing of applications and its role as an administrative tribunal. The budget ramifications in regard to Bill 85 are not yet known, but will be addressed as they present themselves.

Summary of Board Activity for 2012-2013

I am pleased to present, to the Legislative Assembly and to the people of Saskatchewan, a summary of the activities of the Saskatchewan Labour Relations Board (the "Board") for the 2012 – 2013 fiscal year. The Board is an independent, representational tribunal responsible for the interpretation and application of *The Trade Union Act*, *The Construction Industry Labour Relations Act*, and *The Public Service Essential Services Act*.

I started my first term as chairman with amendments pending to The Trade Union Act, as well as the enactment of The Public Service Essential Services Act. Prior to the commencement of my initial term as Chairperson, applicants to the Board were experiencing extreme delays between the hearing of a matter and a decision being reached by the Board. These delays were so extreme, that one of the amendments to The Trade Union Act was an amendment to require that all decisions of the Board be delivered within six months of a hearing being held. It has been my commitment to ensure that the Board achieves this statutory requirement, while at the same time finding means of significantly reducing the number of outstanding cases. I am pleased to report that in 2012 - 2013, the Board has again made significant progress towards these ongoing goals.

The Board received 211 applications/complaints during the 2012 - 13 fiscal year. In addition, the Board received 530 inquiries, to which it provided electronic responses and redirected when appropriate. This is in addition to an estimated 980 telephone inquiries and 275 facsimiles or conventional letter. During the year, we also continued to reduce the backlog of cases awaiting disposition from the Board.

Now, in the dawning of my second term, we have further legislation pending before the legislature, being *The Saskatchewan Employment Act*. This Act makes further changes to the legislative scheme under which the Board operates. The Board's main operational priorities for 2013-14 will be to adapt its processes and rules of practice and procedure as required by *The Saskatchewan Employment Act*. The Board also anticipates that parties will be seeking direction from the Board with respect to new and revised provisions of the new Act, which will require more hearing time to be devoted to those matters by the Board. The Board is confident that it can achieve these goals without significant additional resources, but recognizes that some extra resources will be required.

During the past fiscal year, the Board worked on updating its web site to allow greater access to the public. In the coming fiscal year we also intend to revise and supplement the materials available through our website to allow applicants and other parties seeking the assistance of the Board to better understand the Board's revised or new rules, processes and procedures.

In the past fiscal year, the Board implemented a revised procedure for the scheduling of its hearings through a "Motions Day". Motions Day is normally held on the first Tuesday of each month. While scheduling of hearings is the main rationale for Motions Day, it is also useful for parties to bring forward pre-hearing motions for such matters as document disclosure, provision of particulars as well as adjournment requests. Motions Day was implemented on a trial basis. The trial appears to have been successful. The Board has received positive feedback from the Labour Relations Community concerning continuance of Motions Day.

Between April 1, 2012 and March 31, 2013, the Labour Relations Board sat for a total of 91 days, of which 46 were in Saskatoon and 45 in Regina. This is exclusive of prehearings with various parties, conducted by the Chair, Vice-Chair or Board Registrar. A total of 211 applications were received during the fiscal period, but a total of 515 were disposed of either by the Board or through withdrawal or adjournment during the fiscal year. During 2012-2013, 57 certification orders affecting 3,401 employees were issued by the Board. The Board also rescinded two orders, affecting 20 employees. The tables on page 11 and 12 show these applications; by type of application and disposition. The sixyear trend is shown by disposition in Appendix 3.

Appendix 4 provides a complete listing of all 211 applications brought before the Board during the year. Here is a brief outline of some of the types of issues that the Board faced during the fiscal year.

Wildcat Strike by Concerted Refusal to Work Overtime

MOSAIC POTASH COLONSAY ULC V. UNITED STEELWORKERS UNION, LOCAL 7656; [2012] CANLII 58952

Mosaic Potash Colonsay ULC ("Mosaic") made an interim application to the Board for an injunction against the United Steelworkers Union, Local 7656 (the "Steelworkers"). Mosaic claimed that the Steelworkers were engaged in an unlawful strike by virtue of a concerted refusal by union members to refuse overtime work. No strike vote had been taken by the Union.

Mosaic and the Steelworkers were in negotiations for a new collective agreement. A tentative agreement had been reached by the parties in late July of 2012. Due to an ongoing shutdown at the potash mine at Colonsay operated by Mosaic, the ratification vote on the tentative agreement was not conducted until the week of August 20, 2012. The vote by the Steelworkers members was against ratification of the tentative agreement.

Concurrent with the ratification vote, Mosaic was advised that employees would not work overtime until Mosaic agreed to return to the bargaining table to negotiate further. Evidence supported that Union members did boycott available overtime.

Mosaic advised the Steelworkers that it considered the members refusal to work overtime to be an unlawful strike. The Steelworkers responded that the Union had never asked for, implied, encouraged or condoned any work stoppage, slowdown or specific refusal of overtime by its members.

On the evidence presented, the Board found that Mosaic had proved and arguable case that the Steelworkers were engaged in an unlawful strike and issued an injunction and a cease and desist order against such activity. The Board also ordered that a notice warning members of the consequences of continued strike activity be posted in the workplace.

Compensation to Union for Costs Incurred on Certification Application

UNITED ASSOCIATION OF JOURNEYMEN & APPRENTICES OF THE PLUMBING & PIPEFITTING INDUSTRY OF THE UNITED STATES AND CANADA, LOCAL 179 V. MONAD INDUSTRIAL CONSTRUCTORS INC. AND CONSTRUCTION WORKERS UNION, LOCAL 151

The United Association of Journeymen & Apprentices of the Plumbing & Pipefitting Industry of the United States and Canada, Local 179 (hereinafter "Local 179") applied to be certified as the collective bargaining representative for a group of workers employed by Monad Industrial Constructors Inc. "hereinafter "MICI"). A reply to that application was filed by The Construction Workers Union (CLAC), Local Union No. 151 (hereinafter "CLAC") alleging that the employees of MICI were already certified to be represented by them under a certification order issued by the Board to Monad Contractors Ltd. (hereinafter "Monad"). CLAC alleged that MICI was the successor to Monad.

The Board heard evidence concerning the transfer of certain assets between Monad and MICI which occurred in Alberta. Additionally, MICI had been declared as a successor to Monad in both Alberta and Manitoba. MICI had also confirmed by letter that it considered itself as the successor to Monad for the purposes of collective bargaining.

Based upon the evidence presented, the Board concluded that MICI was the successor to Monad and confirmed that CLAC was the certified bargaining representative of the employees of MICI.

The successorship determination in this case was not unusual. However, the Board utilized its authority under section 5(g) of *The Trade Union Act* to order compensation paid to Local 179 due to the failure of CLAC and MICI to:

- Take any steps in Saskatchewan to amend the certification order made in favour of Monad such as they had done in both Alberta and Manitoba;
- 2. Take any steps to amend the certification order made in favour of Monad upon the confirmation of the transfer of representation rights by letter to CLAC by MICI;
- 3. Take any steps to register a succession of collective agreements between CLAC and Monad or MICI as required by section 30 of *The Trade Union Act*; and
- 4. Take any steps under *The Trade Union Act* to have the Board declare MICI to be the successor to Monad.

These failures resulted in Local 179 expending time, effort and money to organize the employees at MICI, to file an application for certification and to defend that application in the face of the claim of successorship made by CLAC.

Production of Documents in Proceedings before the Board:

In SERVICE EMPLOYEES INTERNATIONAL UNION (WEST), et. al. v. SASKATCHEWAN ASSOCIATION OF HEALTH ORGANIZATIONS, et. al., (2012) 210 C.L.R.B.R (2nd) 229, 2012 CanLII 18139 (SK LRB), LRB File Nos. 092-10, 099-10 & 105-10, the Board reviewed its practices and procedures for the production of documents in proceeding before the Board, including requests for pre-hearing production, production of documents by summons, and production requests that occur in the midst of a hearing.

This case involved allegations by trade unions representing workers in the health care sector that health care employers, together with their representative association (SAHO) and the Government of Saskatchewan, had committed various unfair labour practices during their last round of collective bargaining. In the midst of the hearing into the alleged violations, the applicant trade unions requested disclosure from SAHO. The trade unions sought production of a broad range of documents, including copies of the notes kept by members of the employers' negotiating team from the last round of collective bargaining, SAHO's internal communications, including communications between negotiators and their principals, and external communications, including communications between SAHO and the Government of Saskatchewan regarding the status of collective bargaining. The volume of documents sought by the trade unions was extensive and production of the desired documents was anticipated to delay the hearing by several months. Furthermore, the production request occurred after the applicant trade unions had essentially closed the evidentiary portion of their cases. Nonetheless, the trade unions argued that the desired documents were relevant, probative and necessary to properly respond to the defenses raised by the respondent employers and their association, SAHO. On the other hand, SAHO resisted production of the subject documents on the basis that the information sought was either irrelevant to the matters in dispute between the parties or protected by labour relations privilege. SAHO argued that the trade unions were merely embarking upon an evidentiary "fishing expedition" for either irrelevant or privileged documents.

After reviewing the Board's practices and procedures regarding pre-hearing production of documents, as well as production by *subpoena duces tecum*, the Board went on to outline certain principles that would guide the Board in its determinations with respect to requests for the production of documents occurring in the midst of a hearing:

 The Board noted that applicants seeking production of documents in proceedings before the Board must demonstrate a probative nexus between the documents sought and the matters in issue before the Board and the greater the number of documents sought and the greater the time and expense to locate and produce the desired documents, the stronger the probative nexus that will be expected by the Board.

- 2. The Board noted that broad spectrum requests for production of document are more properly made prior to the commencement of a hearing. While parties have the right to seeking production of documents at any stage in the proceedings, once a hearing into the merits of an application has started, some justification or explanation will be expected for production requests that involve documents that could have been obtained through the Board's pre-hearing procedures, particularly where large volumes of documents are desired and/or where the production of the desired documents will likely cause a delay in the proceedings. Furthermore, the Board noted that, once a party has closed the evidentiary portion of its case, extraordinary justification is required to seek production of large volumes of documents.
- 3. The Board acknowledged that certain documents may be shielded from production because they are protected by a labour relations privilege. The Board noted that the application of this privilege must be assessed by the Board on a "case-by-case" basis. While there is no "blanket" privilege for labour relations communications, the Board noted that the confidentiality of certain types of communications has been acknowledged by the Board as being essential to orderly collective bargaining. For example, the Board noted that the relationship between a negotiator and his/her principals is the kind of relationship that requires confidentiality to promote and enable collective bargaining to occur. The Board was satisfied that collective bargaining requires the parties to be able to make rational and informed decisions regarding their respective bargaining strategies in a sphere of confidentiality. The Board was satisfied that piercing the confidentiality of communications between a negotiator and his/her principals, save in exceptional circumstances, would have a destructive effect on collective bargaining and would tend to undermine industrial relations generally in the province.
- 4. The Board noted that the sphere of confidentiality recognized by the Board as justifying protection in a labour relations context included not only the relationship between principals and their negotiators at the bargaining table but can also included a range of other individuals and third parties involved in providing assistance to both employers and trade unions with their respective collective bargaining strategies.

The Informational Component of Union Security:

In UNITED FOOD AND COMMERCIAL WORKERS, LOCAL 1400 v. WAL-MART CANADA CORP., [2013] 217 C.L.R.B.R. (2d) 103, 2012 CanLII 61524, LRB File No. 164-11, the Board described the nature of the information that an employer in an organized workplace is required to tell new employees when they are being hired for a position falling within the scope of bargaining unit.

In this case, the applicant trade union had alleged that the respondent employer had violated the obligations imposed on it by section 36 of The Trade Union Act because it neither had new employees sign union membership cards nor told them of their obligations to join the trade union as a condition of employment. The employer argued that it complied with it statutory obligations by posting notices provided by the trade union on a bulletin board at the workplace and by advising the union each time it hired a new employee. The Board found that the employer had failed to satisfy the obligations imposed upon it pursuant to s. 36 of The Trade Union Act. The Board concluded that the information that the employer had posted on the bulletin board was both too little (did not provide the requisite information) and came too late (after the employees had already been hired). In addition, the Board expressed concern that new hires might never see the information that had been posted on the bulletin board because of the employer's practice of allowing new postings to cover up old postings on its bulletin board.

The Board noted that workers applying for a job in a unionized workplace need to know that the workplace is organized and they need to know that accepting a job within the scope of a bargaining unit carries with it a statutory obligation to join the representative trade union as a condition of employment. The Board noted that the only person from whom prospective new employees can receive this information on a timely basis (i.e.: before they agreed to accept a job) is from the person hiring them. Thus, the Board concluded that there is an onus on employers in a unionized workplace to ensure that prospective new employees receive at least certain basic information during the interview process, including the fact that the workplace is unionized and the fact that it will be a condition of employment for new employees working within the scope of the bargaining unit to apply for membership in the representative trade union within thirty (30) days of being hired and to maintain said membership for so long as they work within the scope of the bargaining unit unless or until the Labour Relations Board orders otherwise. The Board found that a failure on the part of an employer to provide this information to prospective new employees represented a violation of the obligations imposed on an employer pursuant to section 36 of The Trade Union Act.




