


Labour Relations Board

The Labour Relations Board was created in 1944 with passage of *The Trade Union Act*, S.S. 1944 (2nd Sess.) c. 69. Although the Act has often been amended, most recently in 2008, the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under *The Trade Union Act*. It does this principally through public hearings and written decisions.

The Board's decisions are final and binding upon the parties. There is no appeal, and review by the courts is strictly limited.

The Act presently provides for a board composed of a chairperson and up to two vice-chairpersons and an unspecified number of members. All members of the Board, including the chairperson and vice-chairperson, are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational board. This means that all members of the Board, with the exception of the chairperson and vice-chairperson, are representatives of employees or employers. The chairperson and vice-chairperson are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety, for the Province of Saskatchewan. The Minister is obligated by *The Trade Union Act* to provide the Board with the requisite staff and facilities. The Board operates independently from the Government, its departments and agencies. The chairperson, vice-chairperson and all members of the Board are required by the Act to take an oath of impartiality in the performance of their office.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the Board Registrar, Senior Industrial Relations Officer/Investigating Officer, Executive Assistant to the Chairperson and two clerical positions. The chairperson or the vice-chairperson is appointed to act as Executive Officer of the Board. An Organizational Chart of the Labour Relations Board is contained in Table 1.

The composition of the Board for 2013-2014 was:



Kenneth Love, Q.C. – Chairperson

Kenneth G. Love Q.C., was appointed as Chairperson and Executive Officer of the Saskatchewan Labour Relations Board in March of 2008. He was reappointed to those positions for a further 5 year term in March of 2013.

Prior to his appointment to the Labour Relations Board, Mr. Love was in private practice in the City of Regina. He was named a Queen's Counsel in 1989 and was the recipient of the Canada 125 medal in 1992. Mr. Love obtained his Juris Doctor degree (formerly an LLB) from the University of Saskatchewan and a Bachelor of Arts degree from the same university.



Steven Schiefner – Vice-Chairperson

Steven Schiefner was appointed Vice-Chairperson of the Board in August of 2008. Mr. Schiefner obtained his law degree from the University of Saskatchewan and has been a practicing solicitor since 1994. Prior to that, Mr. Schiefner attended the Alberta College of Arts in Calgary, Alberta, where he studied Commercial and Fine Art, and the University of Regina, where he studied Business Administration and completed his pre-law requirements. Prior to his appointment to the Board, Mr. Schiefner was the City Solicitor for the City of Moose Jaw, a position he had held for over eleven years.

Gloria Cymbalisty

Gloria Cymbalisty was appointed to the Board in March of 1992 as a member representing employees. She is self-employed as an industrial relations consultant. She was formerly a representative for the Saskatchewan Joint Board, Retail, Wholesale and Department Store Union.



Brenda Cuthbert

Brenda Cuthbert was appointed to the Board in July of 1995 as a member representing employers. Ms. Cuthbert is the Vice President of Human Resources for the Siemens Transportation Group Inc.



Donna Ottenson

Donna Ottenson was appointed to the Board in July of 1995 as a member representing employees. A lifetime member of the Saskatchewan Union of Nurses, Ms. Ottenson is a retired Registered Nurse who continues to work part time as an Employment Relations Officer with her union.

The Trade Union Act

In Canada, legislative jurisdiction over industrial relations has, since a ruling of the Supreme Court of Canada in 1925, fallen largely under provincial jurisdiction. Fortunately, the potential this presented for legal fragmentation was offset by varying combinations of inter-provincial management and union structures, common history and common day-to-day economic and political conditions. The result is a remarkable commonality of core principles and procedures in all 11 Canadian jurisdictions.

The main features of Saskatchewan's *Trade Union Act*, like its counterparts in all other Canadian jurisdictions, may be summarized as follows:

- traditional courts are replaced by a specialized, quasi-judicial tribunal with exclusive and binding jurisdiction over the matters assigned to it by *The Trade Union Act*;
- common law of conspiracy and restraint of trade is abolished insofar as it applies to employees who bargain collectively;
- the majority of employees determine for all employees in a group whether they will bargain collectively and, if so, through which union;
- an employer is required to recognize the union chosen by the majority of its employees as their exclusive representative for the purpose of bargaining collectively;
- the employer and the union are required to bargain in good faith with a view to concluding a collective bargaining agreement;
- a number of unfair labour practices are created to protect employees and unions from any attempt by the employer to interfere with their rights;
- strike and lock-out activity is regulated, but not prohibited;
- specific issues, such as union security, technological change, conciliation, voting procedures and religious exclusions are addressed; and
- remedial and enforcement procedures are included in the statute.

In short, the Act provides the legal framework for collective bargaining, along with a procedure for adjudicating disputes and enforcing rights and obligations. *The Trade Union Act*, like its counterparts in all other Canadian jurisdictions, does not attempt to prohibit economic conflict between employees and employers, but only to control it. It does not attempt to regulate the outcome of collective bargaining, but merely the process to be followed.

The function of the Labour Relations Board within this statutory framework is to identify the parties which will participate in collective bargaining, and to monitor the procedural aspects of the bargaining process. Under *The Trade Union Act*, the Board is not required to follow all of the formal rules of procedure that have been developed in courts of law.

The Board attempts to conduct its hearings in a way that will make them accessible to representatives of the parties who have no legal training, and which will allow the Board to identify the issues which are genuinely in dispute.

The Construction Industry Labour Relations Act, 1992, as amended 2010

Passed in 1992 and amended in 2000, *The Construction Industry Labour Relations Act, 1992*, S.S. 1992, c. C-29.11, provides for a system of collective bargaining in the building trades between organizations representing groups of contractors and the construction unions. The supervision of this statutory system is conferred on the Board under the legislation. On July 1, 2010, amendments to the Act, allowed Unions who were not designated by the Minister pursuant to s. 9 of the Act to make application to the Board under s. 5(a), (b) & (c) of *The Trade Union Act* to represent workers within the construction industry. The amendments allowed a trade union to organize an appropriate unit of employees, which may be a multi-trade, or "all employee" unit, as well as a craft, or single-trade unit.

The Health Labour Relations Reorganization Act

Passed in 1996, *The Health Labour Relations Reorganization Act*, S.S. 1996, c. H-0.03, appointed a commissioner to examine the organization of labour relations between health sector employers and employees in the Province. The Dorsey Commission report was submitted, and *The Health Labour Relations Reorganization (Commissioner) Regulations*, R.R.S., c. H-0.03, Reg. 1 came into force, in January, 1997.

The legislation confers upon the Board the power to make orders for the purpose of carrying out the intent of the legislation and respecting any matter arising out of the reorganization of labour relations in the health care sector not addressed in the Regulations.

The Public Service Essential Services Act

The *Public Service Essential Services Act* came into force on May 14, 2008. Under that Act, the Board is authorized to determine the number of employees that will be deemed as essential services, in the event that the Employer and the trade union representing those employees is unable to reach an Essential Services Agreement which specifies which employees are essential services employees in the event of a work stoppage. The legislation also provides the framework for the parties to amend any Essential Services Agreement, if Board intervention is sought by either party. Rules of practice and procedure may be viewed on the Board's website.

Budget Summary

The total budget of the Saskatchewan Labour Relations Board for the fiscal year ending March 31, 2014 was \$1,017,000.00. The actual sum expended by the Board during the fiscal year was \$931,453 representing an under-expenditure of 8.4 per cent as compared to budget. It is of note that although the Board experienced an increase in applications of over 70 per cent as compared to last fiscal period, the Board has been successful in processing the additional matters with only a 6.3 per cent increase in operating costs. The Board continues to display competence in its ability to manage resources efficiently. Given the reality that the Board is unable to control or predict the nature or number of applications put before it, the relationship of expenditure to budgetary allocation cannot be guaranteed from year to year, but is closely monitored. The Board has now fully integrated its records management system allowing for further capacity with little additional costs in regard to processing of applications and its role as an administrative tribunal. The budget ramifications in regard to Bill 85 are not yet known, but will be addressed as they present themselves.

Summary of Board Activity for 2013-2014

It is with great pleasure that I present my annual report to the Legislative Assembly and to the people of Saskatchewan. This report contains a summary of the activities of the Saskatchewan Labour Relations Board (the "Board") for the 2013 – 2014 fiscal year. The Board is an independent, representational tribunal responsible for the interpretation and application of *The Trade Union Act*, *The Construction Industry Labour Relations Act*, and *The Public Service Essential Services Act*.

The Board was extremely busy during the 2013 – 14 fiscal period. It received 362 applications/complaints in the fiscal year, which represented an increase of over 70 percent over the previous year. However, even with this increased filing workload, the Board concluded all **but 119** of those files during the current period. In addition, less than 20 files predate the current fiscal period. In total, the Board concluded 290 matters during this fiscal year. The Board received 832 inquiries through its website, and provided in excess of 1520 responses and redirected inquiries received through telephone or written inquiries.

2013 saw the passage of *The Saskatchewan Employment Act*. In preparation for the proclamation of this new legislation, the Board has prepared and adopted new rules of practice and procedure which will come into effect when *The Saskatchewan Employment Act* is proclaimed in force. The Board anticipates that parties will be seeking direction from the Board with respect to new and revised provisions of the new Act. The Act will also bestow additional jurisdiction and responsibility on the Board with respect to appeals from adjudications made by Employment Standards adjudicators and Occupational Health and Safety adjudicators and special adjudicators. The changes to the Act we anticipate will require more hearing time devoted by the Board in the 2014-2015 fiscal period. The Board is confident that it can achieve these goals without significant additional resources, but recognizes that some additional resources may be required.

In the coming fiscal year we also intend to revise and supplement the materials available through our website so as to allow applicants and other parties seeking the assistance of the Board to better understand the Board's revised or new rules, processes and procedures.

Between April 1, 2013 and March 31, 2014, the Labour Relations Board sat for a total of 129 days, with 65 days in Saskatoon and 64 in Regina, representing an increase of 41 per cent in hearing days. A total of 362 applications were received during the fiscal period, but a total of 290 were

disposed of either by the Board or through withdrawal or adjournment during the fiscal year. During the course of 2013-2014, 38 certification orders involving 693 employees were issued by the Board. The Board also rescinded two orders, affecting 20 employees. Tables 2 and 3 show these applications; by type of application and disposition. The five-year trend is shown by disposition in Tables 4 and 5. Table 7 provides a complete listing of all 362 applications brought before the Board during the year.

In addition, I am pleased to provide brief outline of some of the types of issues that faced the Board during the past fiscal year. The cases which we have heard can be conveniently grouped under a number of headings.

Successorship

Section 37 of *The Trade Union Act* provides that where "a business or a part thereof is sold, leased, transferred or otherwise dealt with" the person acquiring the business is bound by any order's (generally speaking, certification orders) made by the Board. However, what seems straight forward in concept is often difficult to determine in practice.

The Board dealt with several different fact scenarios in the past year. In one case¹, a new owner purchased a hotel through a judicial sale in foreclosure proceedings. While seeking out potential purchasers, the receiver appointed by the court, kept the hotel open for business. At the time the property was sold to the new owner, the hotel was operational but severely distressed. By the time the new owner took possession, the hotel was closed and required extensive repair to reopen. Soon after the hotel re-opened, the hotel suffered water and structural damage as a result of heavy rainfall. Again, the hotel required extensive repairs to reopen.

The Board concluded, for the reasons set out in the decision, that, although the hotel was severely distressed at time of sale, it continued to represent a functional vessel for a hotel business. The Board was satisfied that the essential elements of viable business survived and were transferred to the new owner

In another case², a sawmill had been closed for several years. A company had been interested in purchasing the sawmill prior to its closure, but due to the death of one of its principals, no transaction occurred. After its closure, another company, which included relatives of the principal who had died, purchased the mothballed sawmill. The Union argued that, notwithstanding the closure of the sawmill, that the representational rights should continue. The Company argued that they had not purchased a business, rather they had purchased only assets and therefore, no successorship should be found. For the reasons set out in that case, the Board found that a successorship had occurred.

Another case¹ dealt with an operating subsidiary of a larger composite corporate organization which had been previously certified in Saskatchewan while performing foundation and piling work. The predecessor corporation then withdrew from the Province and discontinued operations here. The alleged successors then begin operating in Saskatchewan some years later. Those alleged successors are subsidiaries within same corporate organization performing various forms of construction work in Saskatchewan.

The Union argued that all named subsidiary companies should be treated as successors. Respondents argue that they are separate and distinct corporate organization performing different functions and should not be seen as successors to work which had never previously been unionized work.

The Board examined the business activities of both the alleged predecessor in Saskatchewan and the work performed by the various subsidiaries at present.

For the reasons set out in the decision, the Board held that only one of the companies carried on the business previously performed by predecessor in Saskatchewan, that of performing foundation and piling work.

Another twist on the issue of when a successorship occurs came into play when one union attempted to organize the employees of a company². In reply to that application, the company took the position that it was already certified to a different union as the result of a transfer of assets which had occurred outside the Province, which transfer of assets, the company asserted was such that the original union to which it was certified was the successor to the new company which was now operating in the Province.

Applications for Summary Dismissal

Amendments were made to *The Construction Industry Labour Relations Act* which permits the Board to certify non craft unions in the construction industry. Since those amendments were enacted, there have been several unsuccessful attempts to have the Board declare the Construction Workers Union to be a company dominated organization. If such declaration were made, that union would not qualify to be a trade union and would not be able to represent employees in the construction industry.

The impacted Union, along with Employers responded to such applications by asking the Board to summarily dismiss those allegations pursuant to sections 18(p) and (q) of the Act³.

The Board's decision was subjected to judicial review and upheld. However, in his decision, Mr. Justice Popescul (as he was then), discussed the Board's approach to summary dismissal applications and commented that he saw the two provisions of the *Act*, which the Board utilized in its determination of summary dismissal matters, as being distinct authorities for the Board which did not require them to be utilized in tandem.

As a result of this discussion, the Board re-examined its procedures and modified the process and test somewhat at paragraph [79], the Board adopted the following⁴:

[79] Taking all of this into consideration, we adopt the following as the test to be applied by the Board on the exercise of its authority under s.18(p) of the *Act*.

1. In determining whether a claim should be struck as disclosing no arguable case, the test is whether, assuming the applicant proves everything alleged in his claim, there is no reasonable chance of success. The Board should exercise its jurisdiction to strike on this ground only in plain and obvious cases and where the Board is satisfied that the case is beyond doubt.
2. In making its determination, the Board may consider only the application, any particulars furnished pursuant to demand and any document referred to in the application upon which the applicant relies to establish his claim.

Additionally, the Board has adopted a procedure to determine if an application for summary dismissal should be dealt with as an *in camera* procedure, or whether the application should be the subject of a hearing. That determination is made by an *in camera* panel who determines if an application should be dealt with by way of written submissions, or if it should be the subject of an oral argument before the Board.

Deferral to Arbitration

One of the Authorities which the Board has under section 18(l) of the *Act* is to defer deciding any matter "if the board considers that the matter could be resolved by arbitration or an alternative method of resolution."

Such deferral is routinely done where there is conflicting jurisdiction between the Board and a grievance arbitrator appointed pursuant to a collective agreement¹. A less usual situation occurred in a case² which involved the Canadian Plan for Settlement of Jurisdictional Disputes in the Construction Industry. In that case, the Teamsters Union felt that they had been denied some of their usual work by PCL Industrial Constructors Inc. in respect of work being done at the Consumers' Co-operative refinery. The Applicant in this case argued the Board should take jurisdiction to determine the issues in dispute. The Respondent argued that the proper jurisdiction for the dispute was the Canadian Plan for Settlement of Jurisdictional Disputes in the Construction Industry. For the reasons given in the decision, the Board agreed to defer to the Canadian Plan for Settlement of Jurisdictional Disputes in the Construction Industry.

Duty of Fair Representation

Applications under section 25.1 of the Act comprise a large percentage of the applications filed with the Board. These applications involve a complaint by a union member that their representative union has not represented that member in grievance and rights arbitration proceedings "in a manner that is not arbitrary, discriminatory or in bad faith". While the parameters of the Board's decisions in this area are well known, there is the occasional twist that comes up. One of these was heard recently by the Board³. In that case, the applicant alleged that she had been "harassed" by the President of the Saskatchewan Federation of Labour and that her union had failed to properly represent her and carry forward her complaint in that regard. The players involved caused some public interest in the case which was heightened by media involvement. For the reasons given in the decision, the Board found that the Union had not failed in its representation of the Applicant. The Board determined that the Union had represented her "in a manner that was not arbitrary, discriminatory or in bad faith". 


