

Labour Relations Board

The Labour Relations Board (the Board) was created in 1944 with passage of *The Trade Union Act*, S.S. 1944 (2nd Sess.) c. 69. Although the Act has often been amended, most recently in 2008, the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under *The Trade Union Act* and since April 29, 2014, *The Saskatchewan Employment Act*. It does this principally through public hearings and written decisions.

The Board's decisions are final and binding upon the parties. There is no appeal, and review by the courts is strictly limited.

The Act presently provides for a board composed of a chairperson and up to two vice-chairpersons and an unspecified number of members. All members of the Board, including the chairperson and vice-chairperson, are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational Board. This means that all members of the Board, with the exception of the chairperson and vice-chairperson, are representatives of employees or employers. The chairperson and vice-chairperson are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety, for the Province of Saskatchewan. The Minister is obligated by *The Saskatchewan Employment Act* to provide the Board with the requisite staff and facilities. The Board operates independently from the government, its departments and agencies. The chairperson, vice-chairperson and all members of the Board are required by the Act to take an oath of impartiality in the performance of their office.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the Board Registrar, Senior Industrial Relations Officer/Investigating Officer, Executive Assistant to the Chairperson and two clerical positions. The chairperson is appointed as Executive Officer of the Board. An Organizational Chart of the Labour Relations Board is contained in Appendix A.

The composition of the Board for 2014-2015 was:

Kenneth Love, Q.C. – Chairperson



Kenneth G. Love Q.C., was appointed as Chairperson and Executive Officer of the Saskatchewan Labour Relations Board in March of 2008. He was reappointed to those positions for a further five year term in March of 2013.

Prior to his appointment to the Labour Relations Board, Mr. Love was in private practice in the City of Regina. He was named a Queen's Counsel in 1989 and was the recipient of the Canada 125 medal in 1992. Mr. Love obtained his Juris Doctor degree (formerly an LLB) from the University of Saskatchewan and a Bachelor of Arts degree from the same university.

Steven Schiefner – Vice-Chairperson



Steven Schiefner was appointed Vice-Chairperson of the board in August of 2008. Mr. Schiefner obtained his law degree from the University of Saskatchewan and has been a practicing solicitor since 1994. Prior to that, Mr. Schiefner attended the Alberta College of Arts in Calgary, Alberta, where he studied

Commercial and Fine Art, and the University of Regina, where he studied Business Administration and completed his prelaw requirements. Prior to his appointment to the Board, Mr. Schiefner was the City Solicitor for the City of Moose Jaw, a position he had held for over eleven years.

Gloria Cymbalisty

Gloria Cymbalisty was appointed to the Board in March of 1992 as a member representing employees. She is selfemployed as an industrial relations consultant. She was formerly a representative for the Saskatchewan Joint Board, Retail, Wholesale and Department Store Union.

Brenda Cuthbert



Brenda Cuthbert was appointed to the Board in July of 1995 as a member representing employers. Ms Cuthbert is the Vice President of Human Resources for the Siemens Transportation Group Inc.

Donna Ottenson



Donna Ottenson was appointed to the Board in July of 1995 as a member representing employees. A lifetime member of the Saskatchewan Union of Nurses, Ms Ottenson is a retired Registered Nurse who continues to work part time as an Employment Relations Officer with her union.

The Saskatchewan Employment Act

With the proclamation of *The Saskatchewan Employment Act* on April 29, 2014, a number of other pieces of legislation were repealed. Those included *The Trade Union Act, The Construction Industry Labour Relations Act, 1992,* and *The Health Labour Relations Reorganization Act.*

In Canada, legislative jurisdiction over industrial relations has fallen largely under provincial jurisdiction since a ruling of the Supreme Court of Canada in 1925. Since then all 11 Canadian jurisdiction have developed core principles and procedures that are remarkably similar. Those principles and procedures were created based on inter-provincial management and union structures as well as a common history and day-to-day economic and political conditions.

The main features of Saskatchewan's current legislation, similar to labour legislation in all other Canadian jurisdictions, may be summarized as follows:

- traditional courts are replaced by a specialized, quasijudicial tribunal with exclusive and binding jurisdiction over the matters assigned to it by *The Saskatchewan* Employment Act;
- common law of conspiracy and restraint of trade is abolished insofar as it applies to employees who bargain collectively;
- the majority of employees determine for all employees in a group whether they will bargain collectively and, if so, through which union;
- an employer is required to recognize the union chosen by the majority of its employees as their exclusive representative for the purpose of bargaining collectively;
- the employer and the union are required to bargain in good faith with a view to concluding a collective bargaining agreement;
- a number of unfair labour practices are created to protect employees and unions from any attempt by the employer to interfere with their rights;

- strike and lock-out activity is regulated, but not prohibited;
- specific issues, such as union security, technological change, conciliation, voting procedures and religious exclusions are addressed; and
- remedial and enforcement procedures are included in the statute.

In short, the Act continues to provide the legal framework for collective bargaining, along with a procedure for adjudicating disputes and enforcing rights and obligations. *The Saskatchewan Employment Act*, like its counterparts in all other Canadian jurisdictions, does not attempt to prohibit economic conflict between employees and employers, only to control it. It does not attempt to regulate the outcome of collective bargaining, but sets out the process to be followed.

The function of the Labour Relations Board within this statutory framework is to identify the parties which will participate in collective bargaining, and to monitor the procedural aspects of the bargaining process. Under *The Saskatchewan Employment Act*, the Board is not required to follow all of the formal rules of procedure that have been developed in courts of law.

The Board attempts to conduct its hearings in a way that will make them accessible to representatives of the parties who have no legal training, and which will allow the Board to identify the issues which are genuinely in dispute.

Budget Summary

The total budget of the Saskatchewan Labour Relations Board for the fiscal year ending March 31, 2015 was \$1,134,000.00. The actual sum expended by the Board during the fiscal year was \$930,571.27 representing an under-expenditure of 17.9 per cent. Although the Board experienced a significant legislative change in which to operate, it has been successful in processing the additional responsibilities and done so well under budget. The Board continues to display competence in its ability to manage resources efficiently. Given that the Board is unable to control or predict the nature or number of applications put before it, the relationship of expenditure to budgetary allocation cannot be guaranteed from year to year,

but is closely monitored. Various measures are ongoing in an effort to reduce budgetary demands and improve service to the stakeholders.

During this past year, the Board finalized its electronic database, allowing for an online resource which can be accessed on the Board's website. The resource allows individuals, unions and employers to access their existing bargaining orders at any time, and will assist them in making amendments or updating their respective information.





Summary of Board Activity for 2014-15

I am again pleased to present my annual report to the Legislative Assembly and to the people of Saskatchewan. This report contains a summary of the activities of the Saskatchewan Labour Relations Board for the fiscal period 2014–15. Foremost among the challenges the Board faced this year was the proclamation of *The Saskatchewan* Employment Act. Under the newly proclaimed legislation the Board continues to act as an independent, representational tribunal responsible for the interpretation and application of the provisions of Part VI of the Act. Concurrent with the proclamation of The Saskatchewan Employment Act, the Government provided the Board additional responsibilities. Those responsibilities are in respect to the appointment of Adjudicators, by the Board, and acting as the appellant body for the decisions of those Adjudicators (as contained at Parts II, III and Part IV of The Saskatchewan Employment Act).

While the number of applications filed with the Board decreased as compared to the previous fiscal period, the Board was nevertheless busy catching up from the large number of applications filed during the previous fiscal period. In addition, during the first 30 days of this fiscal period, the former *Trade Union Act* (TUA) remained operative and the Board received 22 applications during that period. Following the proclamation of *The Saskatchewan Employment Act*, an additional 193 applications were filed under Part VI and 66 matters were received in respect of Parts II, III and IV of *The Saskatchewan Employment Act*. Overall, there was a decrease of 23 per cent in total applications/matters filed, compared to the previous fiscal year.

During the year, the Board concluded 291 matters. The Board also received and responded to 1,026 electronic inquiries. There were also 118 inquiries made by facsimile and through conventional letter, all of which were responded too.

In preparation for the incoming legislation, the Board prepared and adopted new rules of practice and procedure which came into effect when *The Saskatchewan Employment Act* was proclaimed in force. Additionally, new jurisdiction and added responsibilities were given to the Board. This included the Board's role in the selection and appointment

of Adjudicators to hear appeals in respect of decisions made by Employment Standards Branch and the Occupational Health and Safety Branch of the Ministry of Labour Relations and Workplace Safety. Also, the Board became the appellant body of those adjudicative decisions. This has required more time and resources from the Board than were anticipated when the responsibility was assigned to the Board.

Between April 1, 2014 and March 31, 2015, the Labour Relations Board sat for a total of 101 days, with 51 days in Saskatoon and 50 in Regina. A total of 281 applications were received during the fiscal period, but a total of 290 were disposed of either by the Board or through withdrawal or adjournment during the fiscal year.

During the course of 2014-15, 50 certification orders involving 294 employees were issued by the Board. The Board also rescinded four orders, affecting 31 employees. Appendix G show these applications by type of application and disposition. The five-year trend is shown by disposition in Highlights. Appendix F provides a complete listing of all 281 applications brought before the Board during the year.

In addition, I am pleased to provide a brief outline below, of some of the types of issues that the Board faced during the past fiscal year.

Successorship or Contracting Out

During 2014, 3S Health Shared Services Saskatchewan ("3S"), on behalf of the various health regions in Saskatchewan, put out a request for proposals for a third party to provide laundry services to health facilities in the Province. From the request for proposals, 3S entered into discussions with the preferred supplier of those services, K-Bro Linens Systems Ltd ("K-Bro") and ultimately entered into a contract for the supply of linen services.

As a consequence of the transfer of the provision of laundry services several in-hospital laundry facilities would have to close as K-Bro proposed as a part of their response to the Request for Proposals to construct a new laundry facility in Regina to service the health regions. The Joint Board, Retail,

Wholesale and Department Store Union, Local 568 ("Union") represented the employees at the laundry facility operated by the Regina Qu'Appelle Health Region ("RQHR") in Regina. They applied to the Board for a determination that K-Bro was the successor to RQHR in respect of the provision of laundry services. K-Bro, 3S, and RQHR maintained that there was no successorship arising out of the out-sourcing of laundry services as it was a contracting out.

In its decision in SASKATCHEWAN JOINT BOARD, RETAIL, WHOLESALE and DEPARTMENT STORE UNION, LOCAL 568, v. K-BRO LINENS SYSTEMS INC., and THE SASKATCHEWAN ASSOCIATION OF HEALTH ORGANIZATIONS INC., HEALTH SHARED SERVICES SASKATCHEWAN and REGINA QU'APPELLE HEALTH REGION [2014] CanLII 63989, LRB File No. 350-13, a majority of the Board found that the transfer of the laundry services from RQHR to K-Bro did not give rise to successor rights, but was a contracting out.

In that decision, the Board relied upon its established jurisprudence in respect of contracting out of bargaining unit work. In Saskatoon City (Re:) [1998] S.LR.B.D. No. 32, the Board said:

In this instance, the Board does not find that SREDA is a successor employer within the meaning of s 37 of the Act. In our view, the cases establish that the successorship provision does not apply to a situation where a unionized employer alters the manner in which it performs work by paying a contractor to perform a portion of its work for a fee. [emphasis added]

The Board found that no business had been transferred. RQHR was, both before and after the contract with K-Bro, responsible to provide clean linen to patients in its facilities. What had changed was the method whereby that responsibility was being met. The Board noted, with approval, the analysis of the issue that had been provided by the British Columbia Labour Relations Board in a similar case involving K-Bro (Re: K-Bro Linen Systems Inc. [1992] B.C.L.R.B.D. No. 45). In that case, the BC Board provided the following insight at p. 13 of its decision.

...The business of hospitals is to provide health care to patients who need hospital beds and hospital care on either an acute or long term basis. An integral, essential and functionally related aspect of the provision of hospital care is the provision of clean hospital linens – bed linens, bath linens, operating room linens, patient gowns, nursery linens, staff uniforms and a host of other types of linens for other hospital purposes. The provision of a supply of clean linens in reasonable state – to put it in its most basic and simplistic form –is laundry work. Until late 1989, the laundry work was done by the hospitals' own employees on the hospitals' own premises using the hospital's own equipment and supplies. The administrative structure in place at each hospital assumed responsibility for the purchase of linen supplies, the laundering process itself, the quality of the product that resulted and any problems associated with these function. We find that this laundry work as it was performed by the hospitals cannot be described as a viable laundry business, a "dynamic activity", a "going concern", "something which is carried on" by the hospitals (see Metropolitan Parking, above). Perhaps more to the point, although the laundry work is being done by K-Bro now instead of by the hospitals themselves, the hospitals have continued to provide clean linens to their patients.

Failure to Bargain in Good Faith – Bargaining to Impasse

Prior to the proclamation of *The Saskatchewan Employment* Act, firefighters in communities with populations under 20,000 were able to access binding arbitration if they were unable to bargain a collective agreement. This procedure was provided for under The Fire Departments Platoons Act. The collective agreement between the International Association of Fire Fighters, Local 1318, ("Union") and the City of Swift Current ("Employer"), expired in 2012. Some negotiations occurred, but on May 25, 2013, the Union sent notice to the Employer referring the resolution of the collective agreement to binding arbitration under *The Fire Departments Platoons* Act. The Saskatchewan Employment Act had been given Royal assent on May 15, 2013. During the committee stage of the passage of that bill, the committee recommended and the legislature agreed to amend the population limit, from 15,000 to 20,000. This amendment impacted the City of Swift Current and its firefighters as represented by the Union.





In response to the letter from the firefighters, the City of Swift Current advised that it did not accept that an impasse had been reached and reserved its rights to apply to this Board in respect of bad faith negotiations.

The parties first applied to the Court of Queen's Bench for determination of their rights, primarily as to whether or not the Union had access to *The Fire Departments Platoons Act* and binding arbitration. On December 2, 2013, the Court of Queen's Bench ruled that it did not have jurisdiction over this matter and referred the dispute to this Board to adjudicate.

The Board was faced with a preliminary objection from the Union that the application to this Board was filed outside of the six month time period provided for in *The Trade Union Act*. The Board ruled on March 13, 2014 that it would permit the application to proceed and waived the time limitation because of the earlier proceedings wherein the Court had not accepted jurisdiction.

A second hearing was held on May 21, 2014, at which time the Board made an interim order appointing an agent to assist the parties to resolve their differences. That appointment was successful with respect to a related matter in another municipality, but no agreement could be reached in this case. Following a report from the Board's agent, the Board proceeded to determine the issue.

For the reasons set out in its decision in *Swift Current (City) v. International Association of Fire Fighters, Local 1318* [2014] CanLII 76050 (SKLRB), LRB File No. 008-14, the Board found that the Union had not bargained in good faith and had not reached an impasse before referring the matter to arbitration under The Fire Departments Platoons Act. The Board required the parties to bargain collectively and declared the referral to interest arbitration to be null and void.

Appeal from a Decision of an Adjudicator

The Board heard its first appeal from a decision made by an adjudicator under the provisions of *The Saskatchewan Employment Act* in late 2014. Prior to the enactment of the new legislation, appeals from Adjudicator's decisions issued under the authorities of the former *Labour Standards Act* or the *Occupational Health and Safety Act, 1985* were taken to the Court of Queen's Bench. As in the former appeals process,

appeals to this Board may be taken only on questions of law.

In its decision in *Wieler v. Saskatoon Convalescent Home* [2014] CanLII 76051 (SKLRB), LRB File No. 115-14, the Board established both the nature of questions of law which would be considered under its new jurisdiction as well as the standard of review to be applied to those questions.

The Appellant was not successful in her appeal, but has sought leave to appeal the decision (again on a question of law) to the Court of Appeal. The Court has granted leave to appeal (CACV 2636 of 2015).

Common or Related Employer:

In its decision in *IBEW, Local 529 v. Merick Contractors Inc.* [2015] CanLII 19981 (SKLRB), LRB File No. 331-13, the Board considered the common/related employer provisions of *The Trade Union Act* and *The Construction Industry Labour Relations Act*. This case involved three Alberta Corporations that the Union alleged were common or related employers and sought an order declaring them to be common or related employers.

In that decision, the Board considered the criteria which it would examine in determining if a common/related employer designation should be made. Using those criteria, the Board determined that the three corporations were not common/related employers.

In addition, the Board considered its discretion not to make a declaration that employers were common/related employers. The Board determined that in making such a declaration it must satisfy a sufficient labour relations purpose. In this case, the Board found that no purpose would be served by making the requested declaration.

In its decision, the Board also considered the purpose for the making of a common/related employer declaration. The Board determined that the purpose is to prevent the erosion of bargaining rights obtained by a union. In this case, the Board could find no erosion of bargaining rights sufficient to support the requested declaration.

Employer Communications during Collective Bargaining and the Duty to Bargain in Good Faith:

In 2014, the Saskatchewan Labour Relations Board provided guidance on a number of important issues related to collective bargaining, including the scope of permissible communications by an employer and the obligations on employers arising out of the duty to bargain in good faith. This guidance is found in the decision of the Board in *Service Employees International Union (West) v. Saskatchewan Association of Health Organizations, et al.,* (2014) 242 C.L.R.B.R. (2d) 44, 2014 CanLII 17405 (SK LRB), LRB File Nos. 092-10, 099-10 & 105-10.

This case involved allegations by the three provincial health care provider unions (CUPE, SGEU and SEIU-West) that the Saskatchewan Association of Health Organizations, various provincial health care employers and the Government of Saskatchewan had engaged in a variety of unlawful conduct during the 2013 round of collective bargaining. During the course of bargaining, both the employers and the unions engaged in advertising, media campaigns, press releases and communications directly with employees both at home and in the workplace. The unions alleged that the employers had engaged in improper communications. To determine whether the employer had done so, the Board reviewed the scope of permissible and impermissible employer communications and, did so, in light of the 2008 amendments to *The Trade Union Act* involving employer communications.

First, the Board noted that it has historically been reluctant to insert itself into collective bargaining processes as a censor of communications between the parties. The Board noted that collective bargaining is emotionally charged and difficult even for experienced negotiators. As a consequence, the Board has generally adopted a laissez-faire approach when dealing with communications during collective bargaining and particularly so with respect to communications that occur at the table in the heat of the moment. The Board noted that "collective bargaining would undoubtedly grind to a halt in a flood of applications to the Board if we erroneously allowed ourselves to become the arbitrators of civility at the bargaining table".

Second, the Board concluded that the 2008 amendments to The Trade Union Act dealing with employer communication signaled a greater tolerance by the legislature for the capacity of employees to receive information and views from employers without being interfered with, coerced or intimidated. In analyzing impugned communications by an employer, the Board assumes that employees are reasonable, that they are intelligent, and that they possess some resilience and fortitude. The corollary of this conclusion is a weakening of the Board's historic presumption that all communications by an employer are invariably and inherently coercive or intimidating for employees. Now, following the 2008 amendments to The Trade Union Act, the fact that an employer has communicated information and opinions to its employees and those employees have been influenced by those views will not automatically lead to a finding of interference, let alone employer coercion or intimidation. To step outside the sphere of permissible communications, an employer must do more than merely "influence" employees. Rather, an employer must engage in communications that have the potential to compromise or expropriate the free will of employees in the exercise of their protected rights. While there continue to be a number of important limits on the right of an employer to communicate with employees during collectively bargaining, the Board found that unions are not the only permissible source of information about the status of collective bargaining and the proposals being discussed at the table.

The unions also argued that the employers had violated the duty to bargain in good faith by refusing to continue bargaining after a final offer was delivered to the unions. The Board was not persuaded by this argument. The Board was satisfied that the employer had continued to bargain after the final offer was provided to the unions, and it affirmed that the duty to bargain in good faith does not guarantee that unions will receive progressively more attractive offers to replace rejected offers from an employer.

To the contrary, the duty to bargain in good faith requires the parties engage in a process of collective bargaining; that they agree to meet, that they come to the bargaining table prepared to enter into a collective agreement and/or resolve the issues in dispute between the parties through





collective bargaining, that their negotiators have authority to bind their principals, that they explain their proposals and disclose relevant and necessary information that could affect their collective bargaining relationship, and that they not misrepresent the facts or their proposals to the other party. While the duty to bargain requires the parties to engage in a process of collective bargaining, there is no requirement that a particular substantive result will be achieved or avoided through collective bargaining. The Board described the duty to bargain in good faith in the following fashion:

The reality of collective bargaining is that it is a process of resolving conflict through conflict. While The Trade Union Act may regulate that conflict, it also contemplates that a power struggle may well occur between employers and trade unions. The purpose of collective bargaining is to bring the parties together in a setting where they can present their proposals, justify their positions, and search for common ground. Although the parties may have expectations that particular proposals will be agreed to, or that certain kind of concessions will never be asked of them, or that issues will be discussed in a particular order, or that a particular result will be achieved within a certain period of time, there is no guarantee that such will be the case. Each party has the right to attempt to achieve an agreement on terms that it considers advantageous and to adopt strategies intended to advance its own self interests. The parties also have the right to hold firm in their respective positions. The results of collective bargaining flow from the skill of the negotiators, from the prevailing social and economic realities of the day, from the relative strength of the parties, and from their willingness to exercise their respective strength.

The "Application Pending" Statutory Freeze:

In Amalgamated Transit Union, Local 615 v. City of on changes to and funding for the city's pension plan. The city has multiple bargaining relationships with its employees, but all of the city's employees are included within the same pension plan. While the city had achieved an agreement with its eight out of nine bargaining agents, the city was at an impasse with members of the transit union. The city locked out members of the transit union and passed a bylaw to affect changes to the city's pension plan.

Months prior to these actions, the union had filed an application with the Board alleging the city had committed an unfair labour practice unrelated to collective bargaining.

In response to the lockout and the changes to the city's pension plan, the union filed an application with the Board alleging that both of these actions were contrary to the restrictions on industrial action while an application was pending before the Board. The city disputed that its actions were contrary to the "application pending" statutory freeze. The city argued that the union's application was not "pending" at the time it took these actions because that matter had not yet been heard by the Board at a formal hearing. The city also argued that, as the union's application was unrelated to collective bargaining, the union's application was not the type of application that could trigger the statutory freeze.

In response to the union's application, the Board first reviewed the legislative history of the so-called "application pending" statutory freeze. In doing so, the Board concluded that this restriction on industrial action had been part of Saskatchewan labour legislation for over 70 years. The Board noted that the statutory freeze is triggered when "any application" is "first considered" at a "formally constituted meeting." The Board was not satisfied that the legislation only intended the statutory freeze to be triggered by applications related to collective bargaining, and concluded that the legislation was clear that any application involving the parties was sufficient to trigger the statutory freeze. The Board was satisfied that it first considered the disputed application when an in camera panel of the Board began considering that application for purposes of summary dismissal. The Board was satisfied that an in camera hearing was a formally constituted meeting of the Board and that the parties had received notice that Board would be considering the subject application on that particular date. The Board noted that the wording of the legislation was clear, finding that "if the

Legislature had not intended <u>in camera</u> proceedings of the Board to be sufficient to trigger the statutory freeze, it would have said so with express language to that effect when it enacted The Saskatchewan Employment Act."

The Board found that the city had violated the statutory freeze on industrial action while an application was pending before the Board. In response, the Board ordered remedial relief. The city was directed to cease and desist from its lockout and to not engage in another lockout until it had again complied with the notice provisions of The Saskatchewan Employment Act. The city was also directed to pay compensation to members of the transit union for lost wages from the commencement of the lockout until the date the Board disposed of the application giving rise to the statutory freeze. The Board directed that the changes made to the city's pension bylaw would have no force and effect for members of the transit union during the period of the statutory freeze. In granting this relief, the Board declined to grant compensation for the entire period of the lock out and declined to strike down or declare invalid the bylaw that made the impugned changes to the city's pension plan. Rather, the Board confined its remedy to reading down the bylaw during the period of the statutory freeze and granting compensation only for the period of the statutory freeze.

The Board's decision is a cautionary tale that employers and trade unions should determine whether or not they have any applications "pending" before they commence any industrial

The Proper Time for Examining Support Evidence:

Applicant trade unions seeking to obtain bargaining rights and employees seeking to rescind a Certification Order must supply evidence of support when they file their applications with the Board. When an application involving a representational question is first received by the Board, it is examined by staff who conducts an investigation into the validity of the support evidence, as well as the number of employees in the anticipated bargaining unit. If the Board is satisfied that the application is accompanied by the requisite threshold of support (i.e.: 45 percent, now contained at ss. 6-9(2) of The Saskatchewan Employment Act). a representational vote is ordered subject to ss.6-22(2) of

The Saskatchewan Employment Act. This vote is conducted by secret ballot. Whether or not the application is ultimately granted is determined by the results of the representational vote, not the support evidence filed with the application.

In **United Food and Commercial Workers, Local 1400** v. Affinity Credit Union (St. Mary's Branch), (2014) 247 C.L.R.B.R. (2d) 160, 2014 CanLII 42400 (SK LRB), LRB File Nos. 032-14 & 033-14, the Board's practices and procedures for determining the sufficiency of support evidence and conducting representational votes was called into question. In this case, the union had filed a certification application for a unit of employees of approximately 15 employees. The union filed evidence of support from eight of the affected employees. Representational votes are generally conducted quickly. In this case, the review of the certification application and the investigation by staff was completed within hours, and based on that review, the Board was satisfied that the union's application was supported by a sufficient number of employees. A representational vote was ordered by the Board and conducted. However, the ballots remained sealed in the ballot box because a number of issues remained in dispute between the parties.

For example, there were disagreements between the parties as to which employees were eligible to participate in the representational question. Most of these issues were resolved by the parties; save one that was resolved by the Board at the conclusion of a hearing. However, the result of these determinations was that the number of eligible voters grew from 15 to 18. At the conclusion of the hearing, the employer challenged the Board's preliminary decision to conduct a representational vote, arguing that the Union's application was void ab initio when it was subsequently discovered that it was not accompanied by sufficient evidence of support for the total number of employees ultimately discovered to be in the unit. However, the Board refused to rescind its direction for vote and ordered the ballots tabulated.

The Board concluded that the operative time for determining the sufficiency of support evidence is when an application is filed with the Board. Although acknowledging that it does not have the full spectrum of information when an application is initially considered, the Board concluded that

Saskatoon, 2014 CanLII 63995 (SK LRB), LRB File No. 210-14, the Board considered the so-called "application pending" statutory freeze. This case arose out of collective bargaining between the City of Saskatoon and members of its transit union. During bargaining, the parties were unable to agree





the Legislature did not intend the requirement for sufficient support evidence to be applied retrospectively (i.e.: after the representational vote has been conducted).

In coming to this conclusion, the Board noted that the purpose of the requirement for support evidence is to "prevent employees from being asked to decide the representation question if the applicant cannot demonstrate that a sufficient threshold of employees in the workplace support the applicant's initiative". The Board described this requirement as a "shield" to protect the workplace from the disruption associated with applications involving the representational question. The Board concluded that, after a representation vote has been conducted, it would serve no purpose to revisit the decision to order a vote. Simply put, the Board concluded that the decision to direct a representational vote is a preliminary step in the process and that step does not require exact numbers.

The Board also noted the importance of expediency when dealing with the representational question, with the Board using timely pre-hearing votes as a means to shield employees from the undue influences and the inevitable pressures associated with prolonged campaigns in the workplace pending determinations by the Board. The Board concluded that delaying representational votes until the exact number of employees in a workplace is determined would result in significant delays and would expose employees to prolonged campaigning, contrary to the spirit and intent of *The Saskatchewan Employment Act*.

The Board felt that, absent an obvious and overriding error in directing that a pre-hearing representational vote take place, once a vote has been conducted the decision to conduct that vote should not be reviewable. Having considered the evidence, the Board was satisfied that its initial examination into the Union's application was reasonable, as was the decision to direct a pre-hearing vote. The decision of the Labour Relations Board, after being set aside by the Court of Queen's Bench, was upheld by the Saskatchewan Court of Appeal in *United Food and Commercial Workers, Local 1400 v. Affinity Credit Union & Saskatchewan Labour Relations Board*, 2015 SKCA 14 (CanLII).









Appendix B: Applications under *The Trade Union Act*, by Type of Application 2014-15


