Labour Relations Board

The Labour Relations Board (the Board) was created in 1944 with passage of *The Trade Union Act*, S.S. 1944 (2nd Sess.) c. 69 (the Act). Although the Act has often been amended, most recently in 2008, the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under The Trade Union Act and since April 29, 2014, The Saskatchewan Employment Act. It does this principally through public hearings and written decisions.

The Board’s decisions are final and binding upon the parties. There is no appeal, and review by the courts is strictly limited.

The Act presently provides for a board composed of a chairperson and up to two vice-chairpersons, and an unspecified number of members. All members of the Board, including the chairperson and vice-chairperson(s), are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson(s) are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational Board. This means that all members of the Board, with the exception of the chairperson and vice-chairperson(s), are representatives of employees or employers. The chairperson and vice-chairperson(s) are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety for the Province of Saskatchewan. The Minister is obligated by The Saskatchewan Employment Act to provide the Board with the requisite staff and facilities. The Board operates independently from the government, its departments and agencies. The chairperson, vice-chairperson and all members of the Board are required by the Act to take an oath of impartiality in the performance of their office.

The Board’s offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the Board Registrar, Senior Industrial Relations Officer/Investigating Officer, Executive Assistant to the Chairperson, an Assistant to the Registrar and two administrative positions. The chairperson is appointed to act as Executive Officer of the Board. An Organizational Chart of the Labour Relations Board is contained in [Appendix A](#).

Board Members



Kenneth Love, Q.C. - Chairperson

Kenneth G. Love Q.C., was appointed as Chairperson and Executive Officer of the Saskatchewan Labour Relations Board in March of 2008. He was reappointed to those positions for a further five year term in March of 2013.

Prior to his appointment to the Labour Relations Board, Mr. Love was in private practice in the City of Regina. He was named a Queen’s Counsel in 1989 and was the recipient of the Canada 125 medal in 1992. Mr. Love obtained his Juris Doctor degree (formerly an LLB) from the University of Saskatchewan and a Bachelor of Arts degree from the same university.



Graeme Mitchell, Q.C. - Vice-Chairperson

Graeme G. Mitchell, Q.C. was appointed as the Vice-Chairperson of the Saskatchewan Labour Relations Board on March 1, 2016. Mr. Mitchell obtained his Bachelor of Law degree from Osgood Hall Law School at York University as well as a Master of Laws from the University of Chicago Law School. He served as Director of the Constitutional Law Branch, Saskatchewan Ministry of Justice, from 1992 to his appointment to the Board. Mr. Mitchell was appointed as a Queen’s Counsel in 1998. He was honoured with the 2014 Distinguished Service Award by the Canadian Bar Association (Saskatchewan Branch) as well as two Premier’s Awards for Excellence in the Public Service in 2011 and 2013.

Gloria Cymbalisty

Gloria Cymbalisty was appointed to the Board in March of 1992 as a member representing employees. She is self-employed as an industrial relations consultant. She was formerly a representative for the Saskatchewan Joint Board, Retail, Wholesale and Department Store Union.



Brenda Cuthbert

Brenda Cuthbert was appointed to the Board in July of 1995 as a member representing employers. She is the Vice-President of Human Resources for the Siemens Transportation Group Inc.



Hugh Wagner

Hugh Wagner is the General Secretary of the Grain and General Services Union (ILWU-Canada). He joined the GSU as a Staff Representative in January 1975. In October 1977, Wagner was appointed Secretary-Manager of the union which is the Chief Executive Officer position in the organization. In 1994 the position became an elected office of the union and the title was changed to General Secretary. Mr. Wagner has been on the Board since his appointment in July of 1995. Prior to joining the GSU, Mr. Wagner worked in the service sector, the construction industry, and the provincial civil service in Saskatchewan. He was raised in the small town of MacNutt, Saskatchewan, where his family operated a small business. Wagner obtained a Bachelor of Arts (Honours) in Political Science from the Regina Campus of the University of Saskatchewan. Subsequent to joining the GSU, Wagner completed his thesis and obtained a Masters Degree in Political Science from the University of Regina. In addition to his duties with the Grain and General Services Union, Wagner represents the union on a variety of committees, consultative bodies and labour movement forums. He is a member of the Board of Directors of the Western Transportation Advisory Council; and a past Vice-President of the Saskatchewan Federation of Labour. In addition, Mr. Wagner is a member of the Executive Board of the International Longshore and Warehouse Union - Canada and is labour member of the Saskatchewan Labour Relations Board and the Advisory Committee to the Minister of Labour Relations and Workplace Safety.



Duane Siemens

Duane Siemens was appointed to the Board in June 2000 as a member representing employees. Mr. Siemens is a retired millwright from Erco Worldwide. He was the President of CEP Local 609, Secretary and Vice-President of the Saskatchewan Federation of Labour, and past President of the Saskatoon & District Labour Council.



Maurice Werezak

Maurice Werezak was appointed to the Board in July of 2001 as a member representing employees. Mr. Werezak is a past Vice-President of the Saskatchewan Federation of Labour and is President of United Food and Commercial Workers, Local 248-P. Mr. Werezak is a labour representative on the Employment Insurance Appeal Committee and was employed at Mitchell’s Gourmet Foods. He is now retired.



Joan White

First appointed to the Board in July 2001, Joan White is a member representing employers. She holds a BA and an MBA, a Certificate in Labour Relations from Queen’s IRC, and is a Certified Human Resource Professional. Ms. White retired in 2012 following 35 years in human resource management, labour relations, and government relations. She also taught labour relations at the Edwards School of Business.



Mike Wainwright

Mike Wainwright was appointed to the Board in July of 2002 as a member representing employers. Mr. Wainwright is the owner of Mike Wainwright Labour Relations Consulting. He was the Director, HR Business Development for Information Systems Management Canada Corporation (ISM Canada) and has held executive HR positions in the retail and wholesale sectors as well as in the manufacturing sector. Labour Relations Legislation in Saskatchewan

In Canada, legislative jurisdiction over industrial relations has, since a ruling of the Supreme Court of Canada in 1925, fallen largely under provincial jurisdiction. Fortunately, the potential this presented for legal fragmentation was offset by varying combinations of inter-provincial management and union structures, common history and common day-to-day economic and political conditions. The result is a remarkable commonality of core principles and procedures in all 11 Canadian jurisdictions.

The main features of Saskatchewan’s current legislation, like its counterparts in all other Canadian jurisdictions, may be summarized as follows:

- ⇒ traditional courts are replaced by a specialized, quasi-judicial tribunal with exclusive and binding jurisdiction over the matters assigned to it by *The Saskatchewan Employment Act*;
- ⇒ common law of conspiracy and restraint of trade is abolished insofar as it applies to employees who bargain collectively;
- ⇒ the majority of employees determine for all employees in a group whether they will bargain collectively and, if so, through which union;
- ⇒ an employer is required to recognize the union chosen by the majority of its employees, as their exclusive representative for the purpose of bargaining collectively;
- ⇒ the employer and the union are required to bargain in good faith with a view to concluding a collective bargaining agreement;
- ⇒ a number of unfair labour practices are created to protect employees and unions from any attempt by the employer to interfere with their rights;
- ⇒ strike and lock-out activity is regulated, but not prohibited;
- ⇒ specific issues, such as union security, technological change, conciliation, voting procedures and religious exclusions are addressed; and
- ⇒ remedial and enforcement procedures are included in the statute.

In short, the Act continues to provide the legal framework for collective bargaining, along with a procedure for adjudicating disputes and enforcing rights and obligations. *The Saskatchewan Employment Act*, like its counterparts in all other Canadian jurisdictions, does not attempt to prohibit economic conflict between employees and employers, but only to control it. It does not attempt to regulate the outcome of collective bargaining, but merely the process to be followed.

The function of the Labour Relations Board within this statutory framework is to identify the parties which will participate in collective bargaining, and to monitor the procedural aspects of the bargaining process. Under *The Saskatchewan Employment Act*, the Board is not required to follow all of the formal rules of procedure that have been developed in courts of law.

The Board attempts to conduct its hearings in a way that will make them accessible to representatives of the parties who have no legal training, and which will allow the Board to identify the issues which are genuinely in dispute.

Budget Summary

The total budget of the Saskatchewan Labour Relations Board for the fiscal year ending March 31, 2017 was \$1,076,000.00. The actual sum expended by the Board during the fiscal year was \$997,539.24, representing an under-expenditure of 7.3 per cent as compared to the budget. However, this does represent a year-over-year increase in actual expenses of 12.9 per cent which is attributable to the Board experiencing the first full fiscal period in which Adjudicator costs for Parts II and III appeals have been incurred. The cost for adjudicators under Parts II and III this past fiscal period totaled \$91,882.46. The Board has been successful in refining its administrative processes while taking on additional responsibilities. The Board continues to display competence in its ability to manage resources efficiently. Given the reality that the Board is unable to control or predict the nature or number of applications put before it, the relationship of expenditure to budgetary allocation cannot be guaranteed from year to year, but is closely monitored. Various measures are ongoing in an effort to reduce budgetary demands and improve service to the stakeholders.

During this past year, the Board has focused on improving its electronic database, the publication of adjudicative decisions on its website and creating additional online resources which stakeholders can access on the Board’s website. In addition, statutory amendments introduced in *The Saskatchewan Employment Act*, titled *The Extension of Compassionate Care Act, 2016*, transferred the statutory role and authority previously held by the Board to the Registrar of the Board. This has allowed the Registrar to introduce a streamlined process in the appointment of Adjudicators. Although there was no additional cost to the taxpayer, the change reduced the timeframe as Adjudicators were appointed by the Board, during an unrelated hearing, and although no cost was associated with the process, there was an inherent delay. The Registrar continues to gather the information needed to select and appoint an Adjudicator, without calling upon the Board, thereby further assisting in reducing timeframes in processing and also in facilitating and assisting Adjudicators by streamlining the flow of information. These measures provide even timelier access to justice for individuals, unions and employers.

Message from the Chairperson

I am again pleased to present my annual report to the Minister of Labour Relations and Workplace Safety, the Legislative Assembly and to the people of Saskatchewan. This report will be my tenth and final report. I have enjoyed my tenure as Chairperson of the Board and would like to highlight some of the Board’s accomplishments during my term.

New Electronic Database

In 2009, the Board was able to purchase new software in order to create an electronic database of all of its applications. The software chosen was “off the shelf” and required little customization to be utilized by the Board. As necessary, the Board adjusted its processes and procedures to adapt to the new software. The software was, and continues to be, an extremely valuable resource for the Board. Due to the low cost associated with the use of “off the shelf” software, the Board was also able to digitize all of its former records back to its origins in 1946. The Board now has a complete electronic record of its applications from its origin.

Timely Decisions

Prior to my arrival, the Board had a significant issue with the timeliness of its decisions. The Board had been criticized in the legislature and by the Ombudsman in his report “Hearing Back”, which reviewed Administrative Tribunals in the Province. In one instance, there had been a delay of 3 years and five months between the date of the hearing and the date the decision was finally rendered. To insure timely decisions by the Board, the Legislature amended The Trade Union Act to require that Board decisions must be rendered within 6 months of the last hearing date. I am proud to report that the Board has consistently rendered its decisions well before this statutory deadline.

Certification Orders

When The Trade Union Act was amended in 2008 to require a secret ballot vote prior to the Board granting a certification order, there was much criticism of the secret ballot provision. Critics argued that this requirement would unduly delay applications for certification. That has not proven to be the case. In 2006 – 2008, prior to the requirement for a secret ballot vote, the average days from application to order in certification applications was 89 days. Since the implementation of the secret ballot requirement, the Board has streamlined its procedures and has reduced the average number of days (2011-2015) between application and order to 42 days, which includes the time that is required to conduct the secret ballot vote. So, even with the requirement to conduct secret ballot votes, the Board has been able to reduce the time from application to grant or dismissal of the application.

Fewer Staff

Prior to my joining the Board, the Board operated with a Chairperson and two Vice-Chairpersons. Since my appointment, there has only been myself as Chairperson and one Vice-chairperson. For two extended periods there was no Vice-chairperson (From March 6, 2008 until the appointment of Steven Schiefner as Vice-chairperson on August 18, 2008 and again when Mr. Schiefner was appointed as a Provincial Court Judge, November 13, 2015 until the appointment of Graeme Mitchell as Vice-chairperson February 25, 2016), or a part-time Vice-chairperson when Mr. Schiefner was seconded to assist with the R.M. of Sherwood Council governance issue.

The Board has also operated without the services of a senior labour relations officer. This position was filled at the time that I was appointed in 2008, but has remained vacant since the resignation of the staff person in that position in 2009.

Enhanced Workload

In addition to utilizing fewer staff positions, the Board has also had its workload increased through amendments made when The Saskatchewan Employment Act came into force on April 29, 2014. That Act provided that the Board should hear appeals launched from decisions of Adjudicators appointed to hear complaints under the Employment Standards and Occupational Health and Safety provisions of that Act. In addition to hearing the appeals under these provisions, the Board was also tasked with the responsibility to make the appointments of these adjudicators and to manage payments and other administration of the adjudicators.

To promote transparency and consistency in the decisions made by adjudicators, the Board also undertook to have all decisions by adjudicators published on its website. Those decisions are now available for review by members of the public, the labour relations community and other adjudicators who can utilize those decisions to assist them in their deliberations.

Budgetary Prudence

Notwithstanding the timeliness improvements and the additional responsibilities, the Board has proved to be fiscally prudent in the expenditure of its authorized budget. I am proud to advise that during my tenure as Chairperson, the Board has never expended its full budget or exceeded its budgetary allocation. In each year, any budgetary surplus has been returned to the general revenue fund.

Second Longest Serving Chairperson

I am the second longest serving Chairperson since the Board was first established in 1946. My term of office as Chairperson is second only to Mr. P.G. Makaroff Q.C. who served from 1949-1964. Additionally, I am also the second longest currently serving Chairperson of a Labour Relations Board in Canada.

Summary of Board Activity for 2016-17

Between April 1, 2016 and March 31, 2017, the Labour Relations Board sat for a total of 106 days, with 32 days in Saskatoon and 74 in Regina. A total of 292 applications were received during the fiscal period and a total of 254 were disposed of either by the Board or through withdrawal or adjournment during the fiscal year. During the course of 2016-17, 32 certification orders involving 642 employees were issued by the Board. The Board also rescinded three orders, impacting 126 employees. The Highlights Table show these applications by type of application and disposition. The six-year trend is shown by disposition at [Appendix C](#). [Appendix E](#) provides a complete listing of all 292 applications brought before the Board during the year.

I am pleased to provide brief outline of some of the types of issues that faced the Board during the past fiscal year.

SASKATCHEWAN JOINT BOARD, RETAIL, WHOLESALE and DEPARTMENT STORE UNION, LOCAL 568, Applicant v. K-BRO LINENS SYSTEMS INC., Respondent and THE SASKATCHEWAN ASSOCIATION OF HEALTH ORGANIZATIONS INC., HEALTH SHARED SERVICES SASKATCHEWAN and REGINA QU’APPELLE HEALTH REGION, Respondent Employers

A decision of the Board from the prior year which had determined that the reorganization of Laundry Services for The Regina Qu’Appelle Health Region was a contracting out was submitted by the Union for judicial review. On review, the Court of Queen’s Bench for Saskatchewan upheld the decision of the Board, but returned one question to the Board for further consideration as to whether or not any or some of the Respondents were “common or related employers.” On further consideration, the Board found that none of the Health entities were common or related employers with K-Bro Linen Services Inc.

CLR CONSTRUCTION LABOUR RELATIONS ASSOCIATION OF SASKATCHEWAN INC., Applicant v. INTERNATIONAL ASSOCIATION OF HEAT AND FROST INSULATORS AND ASBESTOS WORKERS, LOCAL 119, Respondent

In this application, the Registered Employer Organization (“REO”) filed an unfair labour practice application against the Union alleging that the Union entered into a “Labour Supply Agreement” with a non-unionized contractor engaged in work that was normally performed by employers who were represented by the REO for collective bargaining.

The Board reviewed the nature and purpose for the Construction Industry bargaining requirements as set out in Division 13 of *The Saskatchewan Employment Act*. It noted that the issue in this case was the applicability of Division 13 provisions to employers who were not certified by the Board. On review, a majority of the Board determined that the non-certified employer was, by virtue of the provisions of Division 13, a “unionized employer” for the purposes of the Act.

Because the employer was found to be a “**unionized** employer”, a majority of the Board found the Union guilty of an Unfair Labour Practice in negotiating directly with the employer for the supply of labour to its project.

SASKATOON PUBLIC LIBRARY BOARD, Applicant v. CANADIAN UNION OF PUBLIC EMPLOYEES, LOCAL NO. 2669, Respondent Union and GOVERNMENT OF SASKATCHEWAN, Respondent and SASKATCHEWAN GOVERNMENT AND GENERAL EMPLOYEES’ UNION, SASKATCHEWAN JOINT BOARD, RETAIL WHOLESALE AND DEPARTMENT STORE UNION and THE CITY OF REGINA, Intervenors

This case required the Board to examine and interpret the provisions of *The Saskatchewan Employment Act* which came into force on April 29, 2016. Those provisions required the Board to exclude any “supervisory employees” from a unit of employees which included employees who were supervised by those “supervisory employees”.

The Saskatoon Library Board, along with a number of other employers, applied to the Board to have “supervisory employees” excluded from existing bargaining units. The application by the Saskatoon Public Library was chosen as the “test” case for those applications.

The Union’s involved (primarily CUPE) also served notice under *The Constitutional Questions Act*, requesting the Board consider whether or not the provisions, as enacted, offended the *Canadian Charter of Rights and Freedoms*.

The Board heard evidence and argument concerning the proper interpretation of the statutory provisions. The Board determined that the modern rule of statutory interpretation and other tools of statutory interpretation lead to the conclusion that the provision “must be restricted to applications made by a trade union for certification or a new unit of employees or in respect of applications made by a trade union to certify part of a current bargaining unit out of a larger bargaining unit.” The Board concluded that the provision did not permit an employer to make an application to remove employees already within a bargaining unit from that bargaining unit.

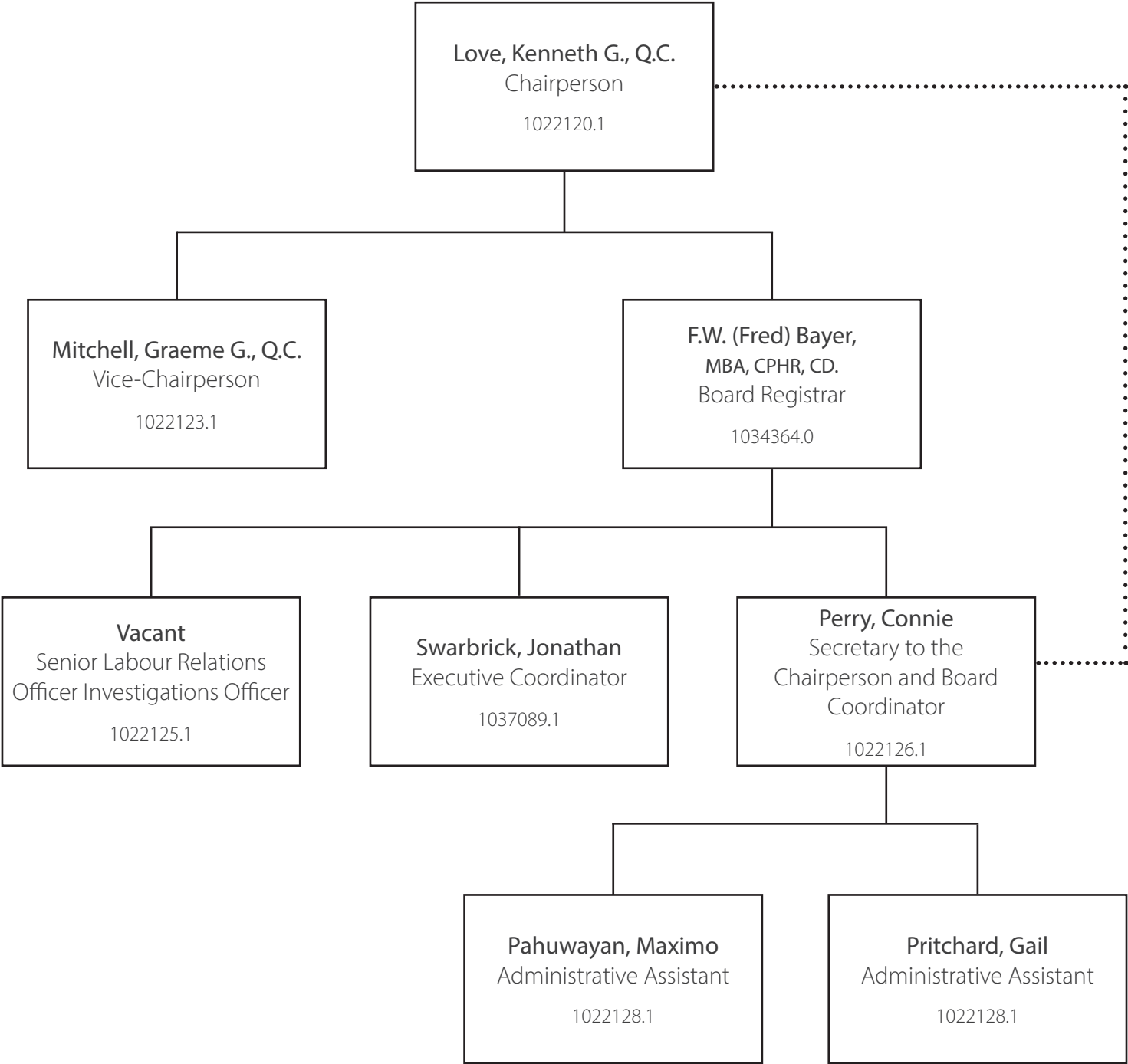

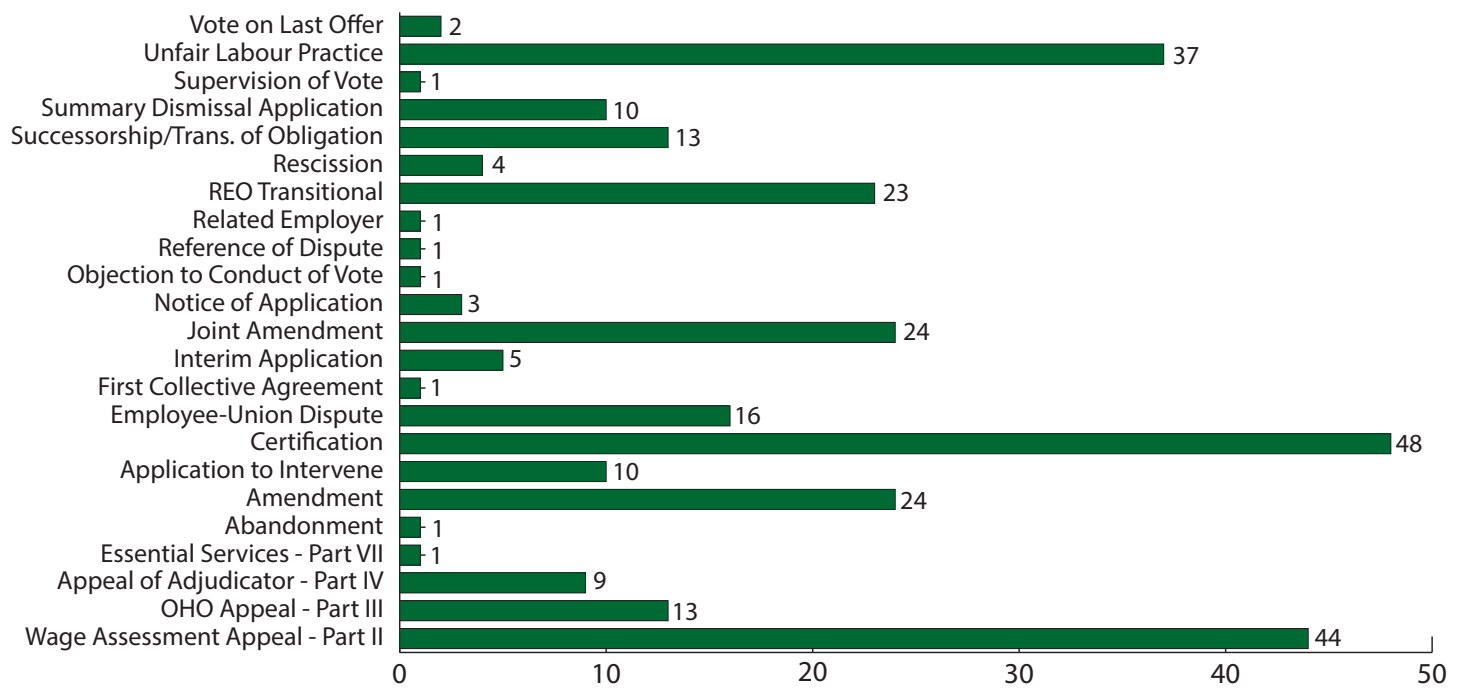

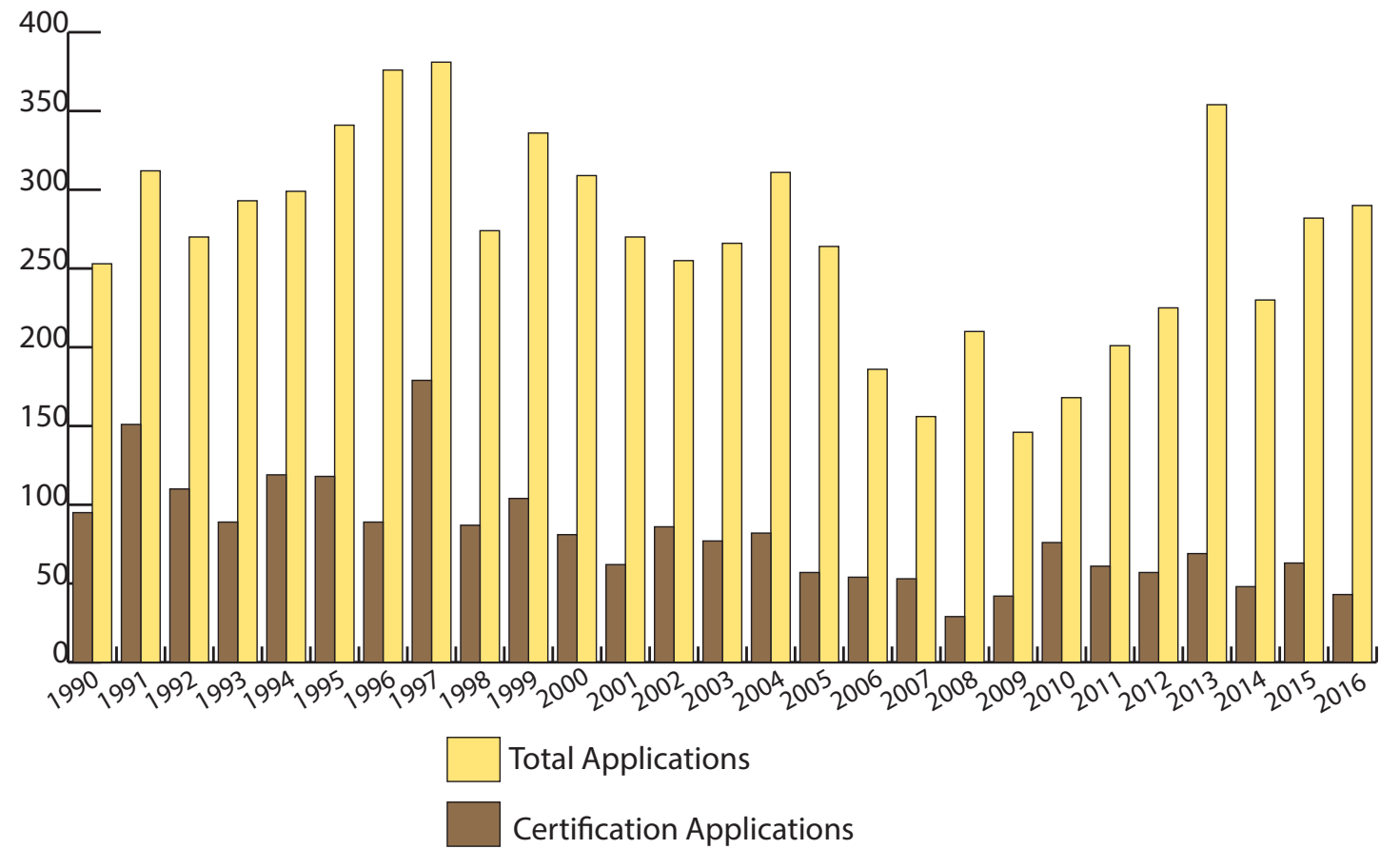
