Labour Relations Board

The Labour Relations Board was created in 1944 with passage of The Trade Union Act, S.S. 1944 (2nd Sess.) c. 69. Although the Act was often amended, and, in 2014, replaced by The Saskatchewan Employment Act, the basic concept of the Board has not changed. The Board is an independent, guasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under The Saskatchewan Employment Act. It does this principally through public hearings and written decisions. The Board's decisions are final and binding on the parties. There is no appeal, and review by the courts is strictly limited.

The Act provides for a board composed of a chairperson and up to two vice-chairpersons, and an unspecified number of members. All members of the Board, including the chairperson and vice-chairperson(s), are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson(s) are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational Board. This means that all members of the Board, with the exception of the chairperson and vicechairperson(s), are representatives of employees or employers. The chairperson and vice-chairperson(s) are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety for Saskatchewan. The Minister is obligated by the Act to provide the Board with any technical, clerical and administrative assistance that the Board reasonably requires. The Board operates independently from the government, its ministries and agencies.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the Board Registrar, Senior Labour Relations Officer/Investigating Officer, Secretary to the Chairperson, Board Officer and two administrative positions. The Chairperson is the Executive Officer of the Board. An Organizational Chart of the Labour Relations Board is contained in Appendix A: Saskatchewan Labour Relations Board Organizational Chart.

Susan C. Amrud Q.C. – Chairperson

Susan C. Amrud, Q.C. was appointed as Chairperson of the Saskatchewan Labour Relations Board effective March 7, 2018. Ms. Amrud practiced law with the Saskatchewan Ministry of Justice for 34 years, most recently as Associate Deputy Minister. Her practice focused on legislative development. For 15 years she led a team of lawyers that provided advice to government on constitutional, human rights, trade and Aboriginal law issues as well as the development, drafting and publication of legislation and the operation of public registries. She was awarded the Queen Elizabeth II Diamond Jubilee Medal in 2012 and the Premier's Award for Excellence in the Public Service in 2013 as part of The Saskatchewan Employment Act Development Team. Graeme Mitchell, Q.C. - Vice-Chairperson






Laura Sommervill





Kent Kornelsen




Shelley Boutin-Gervais

Labour Relations Legislation in Saskatchewan

In Canada, legislative jurisdiction over industrial relations has, since a ruling of the Supreme Court of Canada in 1925, fallen largely under provincial jurisdiction. Fortunately, the potential this presented for legal fragmentation was offset by varying combinations of inter-provincial management and union structures, common history and common day-to-day economic and political conditions. The result is a remarkable commonality of core principles and procedures in all Canadian jurisdictions.

The main features of Saskatchewan's legislation, like its counterparts in all other Canadian jurisdictions, may be summarized as follows:

- to it by The Saskatchewan Employment Act;
- which union;
- the purpose of bargaining collectively;
- agreement;
- interfere with their rights:
- ⇒ strike and lock-out activity is regulated, but not prohibited;
- essential services are addressed; and
- ⇒ remedial and enforcement procedures are included.

In short, the Act provides the legal framework for collective bargaining, along with a procedure for adjudicating disputes and enforcing rights and obligations. Like its counterparts in all other Canadian jurisdictions, The Saskatchewan Employment Act does not attempt to prohibit economic conflict between employees and employers, but only to control it. It does not attempt to regulate the outcome of collective bargaining, but merely the process to be followed.

The function of the Labour Relations Board within this statutory framework is to identify the parties which will participate in collective bargaining, and to monitor the procedural aspects of the bargaining process. The Board is not required to follow all of the formal rules of evidence and procedure that have been developed in the courts. The Board conducts its hearings in a way that will make them accessible to representatives of the parties who have no legal training, and which will allow the Board to identify the issues which are genuinely in dispute.

In 2014 the Board also became responsible for appointing adjudicators to hear appeals from decisions of the Director of Employment Standards and Director of Occupational Health and Safety, and hearing appeals from the decisions of those adjudicators.

Budget Summary

The budget of the Saskatchewan Labour Relations Board for the fiscal year ending March 31, 2018 was \$1,021,000.00. The actual sum expended by the Board during the fiscal year was \$992,713.06, representing an under-expenditure of 2.77 per cent as compared to the budget. This represents a slight decrease as compared to the previous fiscal year. Adjudicator costs for matters under Parts II and III were \$61,034.86 and \$13,645.65 respectively. Given that the Board is unable to control or predict the nature or number of applications put before it, the relationship of expenditure to budgetary allocation cannot be guaranteed from year to year, but is closely monitored. Various measures are ongoing in an effort to reduce budgetary demands and improve service to the stakeholders.

During this year, the Board became aware of the need to update its electronic database to align with government-wide software updates. This will allow the Board to maintain its online calendar of hearings in real time. The Board publishes adjudicators' decisions on the Board's website in addition to the Board's decisions, providing an easily accessible online resource for stakeholders to access.






