Labour Relations Board

The Labour Relations Board (Board) was created in 1944 with passage of *The Trade Union Act*. Although this legislation was often amended, and, in 2014, replaced by The Saskatchewan Employment Act (Act), the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under the Act. It does this principally through public hearings and written decisions. The Board's decisions are final and binding on the parties. There is no appeal from decisions pursuant to Part VI, and review by the courts is strictly limited.

The Act provides for a Board composed of a chairperson and up to two vice-chairpersons, and an unspecified number of other members. All members of the Board, including the chairperson and vice-chairperson(s), are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson(s) are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational one. This means that all members of the Board, with the exception of the chairperson and vicechairperson(s), are representatives of organized employees or employers. The chairperson and vice-chairperson(s) are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety for Saskatchewan. The minister is obligated by the Act to provide the Board with any technical, clerical and administrative assistance that the Board reasonably requires. The Board operates independently from the government, its ministries and agencies.

The Board's offices and staff are located at 1600-1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the Board registrar, secretary to the chairperson, Board officer and an administrative support position. The chairperson is the executive officer of the Board. An organizational chart of the Board is contained in Appendix A.

Board Members



Susan C. Amrud, Q.C. – Chairperson

Susan C. Amrud, Q.C. was appointed as chairperson of the Board effective March 7, 2018. Amrud practiced law with the Saskatchewan Ministry of Justice for 34 years, most recently as associate deputy minister. Her practice focused on legislative development. For 15 years she led a team of lawyers that provided advice to government on constitutional, human rights, trade and Aboriginal law issues as well as the development, drafting and publication of legislation and the operation of public registries. She was awarded the Queen Elizabeth II Diamond Jubilee Medal in 2012 and the Premier's Award for Excellence in the Public Service in 2013 as part of The Saskatchewan Employment Act Development Team.

Barbara Mysko – Vice-Chairperson



Barbara Mysko was appointed as vice-chairperson of the Board on February 19, 2019. Mysko obtained her Bachelor of Common Law and Bachelor of Civil Law from McGill University as well as a Master of Arts from Dalhousie University. She acted as senior Crown counsel with the Constitutional Law Branch, Saskatchewan Ministry of Justice, immediately prior to her appointment to the Board. As counsel with the ministry since 2009, Mysko acted as a litigator on major cases involving human rights, labour, and Charter issues. Mysko was awarded the Pro Bono Service Award in 2016 as a member of the Immigration and Refugee Panel. She was elected as a Bencher for the Law Society of Saskatchewan in November, 2018.



Gerald Tegart, Q.C. – Vice-Chairperson

Gerald Tegart was appointed as vice-chairperson of the Board on February 27, 2020. Tegart grew up in rural Saskatchewan and attended university in Regina and Saskatoon, obtaining degrees in Civil Engineering and Law. During his 37-year career with the Saskatchewan Ministry of Justice, he served as a Crown prosecutor, provided legal services to multiple ministries and was a senior legal manager. He was Saskatchewan's Deputy Minister for the Ministry of Justice and Deputy Attorney General from 2009 to 2013. Since leaving public service, he has focused his law practice on labour arbitrations and other adjudicative matters, and has also served as an advisor to businesses and government organizations. He is currently the immediate past president of the Law Society of Saskatchewan.

Hugh Wagner

Hugh Wagner is the general secretary of the Grain and General Services Union (GSU) (ILWU•Canada). Prior to joining the GSU in 1975, Wagner worked in the service sector, the construction industry, and the provincial civil service in Saskatchewan. He obtained a Bachelor of Arts (Honours) in Political Science from the Regina Campus of the University of Saskatchewan. Subsequent to joining the GSU, Wagner obtained a Masters Degree in Political Science from the University of Regina. He is a past member of the board of directors of the Western Transportation Advisory Council; and a past vice-president of the Saskatchewan Federation of Labour. Wagner is a member of the executive board of the International Longshore and Warehouse Union - Canada and is a labour member of the Board and the Advisory Committee to the Minister of Labour Relations and Workplace Safety.

Maurice Werezak



Maurice Werezak was appointed to the Board in 2001 as a member representing employees. Werezak is a past vice-president of the Saskatchewan Federation of Labour and is president of United Food and Commercial Workers, Local 248-P. Werezak is a labour representative on the Employment Insurance Appeal Committee and was employed at Mitchell's Gourmet Foods. He is now retired.

Clive Tolley

Clive Tolley was appointed to the Board in 2021 as a member representing employers. Tolley is a self-employed chartered arbitrator and chartered mediator with more than 20 years of experience in labour relations and adjudication. He has a Bachelor of Arts from the University of Regina and a Dispute Resolution Advanced Certificate from Saskatchewan Polytechnic. As a former city councillor in the City of Moose Jaw, Tolley remains involved in his community as he serves as a member of the quasi-judicial Board of Revision hearing appeals.

Mike Wainwright

Mike Wainwright was appointed to the Board in 2002 as a member representing employers. Wainwright is the owner of Mike Wainwright Labour Relations Consulting. He has held executive human resources positions in the retail and wholesale sectors as well as the manufacturing sector. He also served over 25 years on the Expert Committee on Human Resources, Saskatchewan Chamber of Commerce.

Vince Engel



Vince Engel is a retired insulator who was elected business manager of the International Association of Heat and Frost Insulators Local 119, Saskatchewan in 1996. In 2002 he was appointed to the position of Canadian director of organizing, and in 2010 became the International Heat and Frost Insulators Union's vice-president responsible for western Canada. Engel served on the General Presidents' Maintenance Committee, the National Maintenance Committee and the Canadian National Building Trades Council until he retired in 2019.



Shawna Colpitts

Shawna Colpitts was appointed to the Board in 2007 as a member representing employees. Colpitts was the director of political action and education with Service Employees' International Union (SEIU)-West until she retired in May of 2021. Prior to this she was a national representative for SEIU Canada. 
Brian L. Barber

Saskatchewan Labour Relations Board COVID-19 Response Highlights

Overview

The COVID-19 pandemic has challenged government operations during the 2020-21 fiscal year. The expected operations of programs and services may have significantly changed as the Government of Saskatchewan worked quickly to support citizens and businesses. Annual reports for the 2020-21 fiscal year provide information on the impacts of COVID-19 and recognize the work of the Government of Saskatchewan in responding to the pandemic.

Organization COVID-19 Response Highlights

- The Board adjourned all in-person hearings and began development of a COVID-19 policy and plan to hear matters without risk to parties, stakeholders or staff on the issuance of the first public health orders regarding the COVID-19 pandemic.
- Case management conferences were conducted by video conference with parties as early as March 2020 to manage the needs • and expectations of stakeholders and minimize the impact of the pandemic on matters that required a hearing.
- In the COVID-19 policy, the Board developed a procedure for hearings to be conducted by video conference and began conducting hearings by video conference in June 2020.
- Hearings conducted by video conference continued to be the default at the end of the 2020-21 fiscal year and have been • widely accepted by the labour relations community.
- Parties were permitted to file requests for hearings to be conducted in-person to insure that all stakeholders would continue to have access to justice at the Board, regardless of their level of technological access.
- Strict safety protocols were set in place during any in-person hearings to reduce the possible infectious vectors to an absolute minimum
- Under the COVID-19 policy, the Board has remained available for inquiry by phone, email, or mail but public access to the Board offices has remained restricted with the exception of rare in-person hearings.
- At the onset of the pandemic, the Board reduced the presence of staff in the Board offices and transitioned staff to a workfrom-home arrangement with rotational attendance in the Board offices. This arrangement has continued through the end of the fiscal year.
- Despite the pandemic, the Board managed to draft updated regulations and conduct consultations with stakeholders, concluding with the new regulations coming into force on April 1, 2021.






