Labour Relations Board

The Labour Relations Board was created in 1944 with passage of *The Trade Union Act*. Although this Act was often amended, and, in 2014, replaced by *The Saskatchewan Employment Act* (Act), the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under the Act. It does this principally through public hearings and written decisions. The Board's decisions are final and binding on the parties. There is no appeal from decisions pursuant to Part VI, and review by the courts is strictly limited.

The Act provides for a Board composed of a chairperson and up to two vice-chairpersons, and an unspecified number of other members. All members of the Board, including the chairperson and vice-chairperson(s), are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson(s) are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational one. This means that all members of the Board, with the exception of the chairperson and vice-chairperson(s), are representatives of organized employees or employers. The chairperson and vice-chairperson(s) are neutral and are lawyers. The Board reports to the Minister of Labour Relations and Workplace Safety for Saskatchewan. The Minister is obligated by the Act to provide the Board with any technical, clerical and administrative assistance that the Board reasonably requires. The Board operates independently from the government, its ministries and agencies.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the board registrar, secretary to the chairperson, board officer, board clerk and an administrative support position. The chairperson is the executive officer of the Board. An organizational chart of the Board is contained in Appendix A: Saskatchewan Labour Relations Board Organizational Chart.

Board Members



Michael J. Morris, K.C. – Chairperson

Michael J. Morris, K.C. was appointed as chairperson of the Saskatchewan Labour Relations Board on March 8, 2023. Mr. Morris is an alumnus of the University of Saskatchewan (LL.B., Gr. Dist.) and the University of Melbourne (LL.M.) and served as a clerk for the Saskatchewan Court of Appeal. Prior to his appointment to the Board he worked in private practice, as a Crown prosecutor, and most recently with the Civil Law Branch of the Ministry of Justice and Attorney General in Saskatchewan, where he served as the director of litigation. Mr. Morris' litigation-focused career has provided him with experience in diverse legal issues before various decision-makers. He was honoured with a King's Counsel designation in 2018.



Barbara Mysko – Vice-Chairperson

Barbara Mysko was appointed as vice-chairperson of the Saskatchewan Labour Relations Board on February 19, 2019. Ms. Mysko obtained her Bachelor of Common Law and Bachelor of Civil Law degrees from McGill University as well as a Master of Arts from Dalhousie University. She acted as senior Crown counsel with the Constitutional Law Branch, Saskatchewan Ministry of Justice, immediately prior to her appointment to the Board. As counsel with the ministry since 2009, Ms. Mysko acted as a litigator on major cases involving human rights, labour, and Charter issues. Ms. Mysko was awarded the Pro Bono Service Award in 2016 as a member of the Immigration and Refugee Panel.



Hugh Wagner

Hugh Wagner retired as the General Secretary of the Grain and General Services Union (ILWU•Canada) on March 24, 2023 after completing 48 years of service with the union. Wagner holds a Bachelor of Arts (Honours) Degree in Political Science from the Regina Campus of the University of Saskatchewan. Subsequent to joining the GSU, Wagner completed his thesis and obtained a Masters Degree in Political Science from the University of Regina. In addition to his duties with the Grain and General Services Union, Wagner served the union and the labour movement in a wide variety of forums, committees and consultative bodies. Wagner has served as labour member of the Saskatchewan Labour Relations Board since 1995.



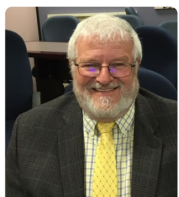
Maurice Werezak

Mr. Werezak is a past vice-president of the Saskatchewan Federation of Labour and is president of United Food and Commercial Workers, Local 248-P. Mr. Werezak is a labour representative on the Employment Insurance Appeal Committee and was employed at Mitchell's Gourmet Foods. He is now retired.

Clive Tolley was appointed to the board in 2021 as a member representing employers. Mr. Tolley is a self-employed chartered arbitrator and chartered mediator with more than 20 years of experience in labour relations and adjudication. He has a Bachelor of Arts from the University of Regina and a Dispute Resolution Advanced Certificate from Saskatchewan Polytechnic. Mr. Tolley was elected Mayor of Moose Jaw in November, 2021.

Mike Wainwright was appointed to the Board in 2002 as a member representing employers. Mr. Wainwright is the owner of Mike Wainwright Labour Relations Consulting. He has held executive human resources positions in the retail and wholesale sectors as well as the manufacturing sector. He also served over 25 years on the Expert Committee on Human Resources, Saskatchewan Chamber of Commerce.

Kris Spence was appointed to the Board in June 2022 as a member representing employers. Ms. Spence is a Total Rewards professional at The Mosaic Company, a global crop nutrient company with operations in nine countries and over 13,000 employees worldwide. Ms. Spence has 25 years' experience working in the field of Human Resources with expertise in Total Rewards and Labour Relations; and holds Bachelor of Commerce (B.Comm) and Bachelor of Laws (LL.B) degrees from the University of Saskatchewan.



Vince Engel

Vince Engel is a retired insulator who was elected business manager of the International Association of Heat and Frost Insulators Local 119, Saskatchewan in 1996. In 2002 he was appointed to the position of Canadian director of organizing, and in 2010 became the International Heat and Frost Insulators Union's vice-president responsible for Western Canada. Mr. Engel served on the General Presidents Maintenance Committee, the National Maintenance Committee and the Canadian National Building Trades Council until he retired in 2019.

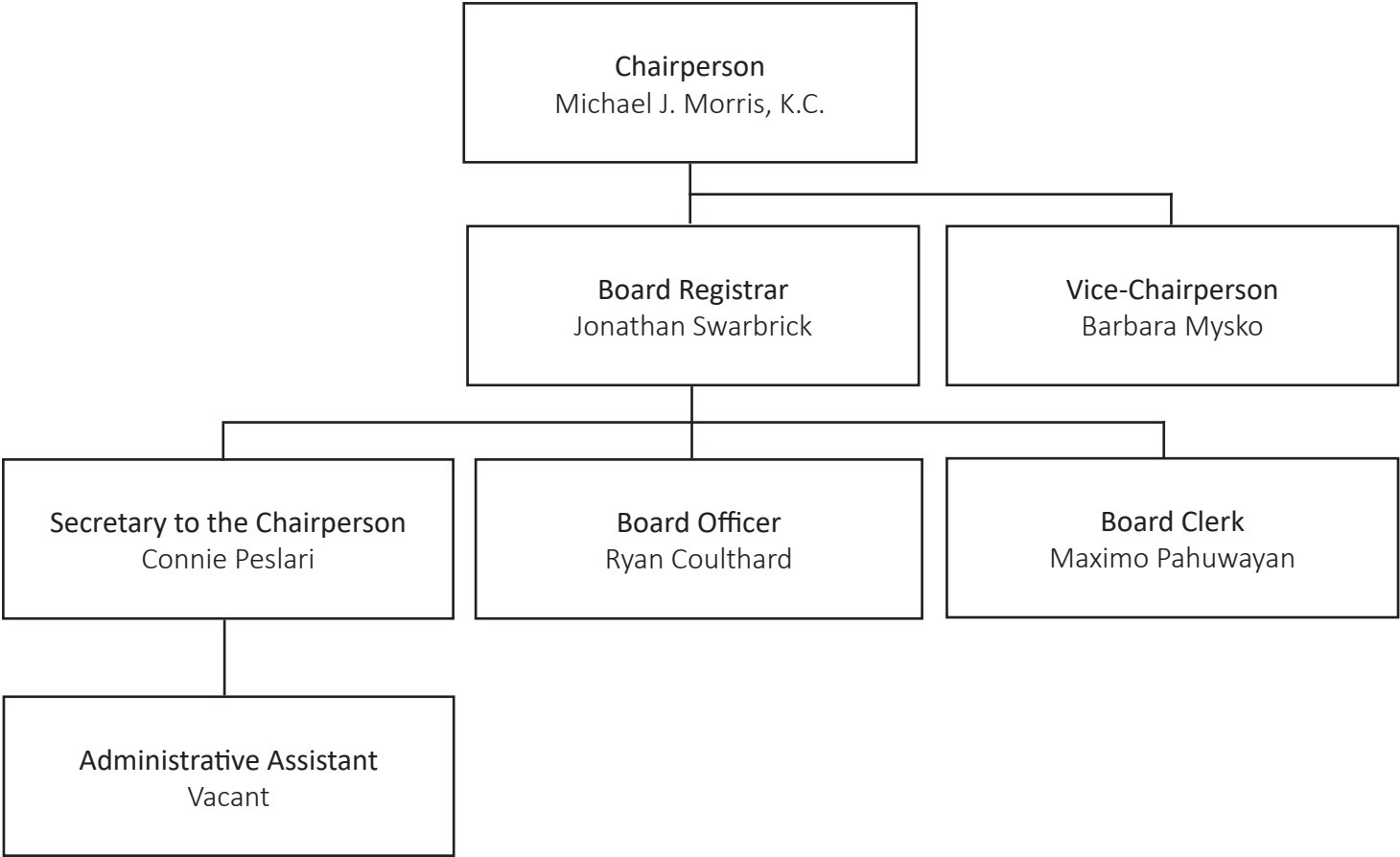

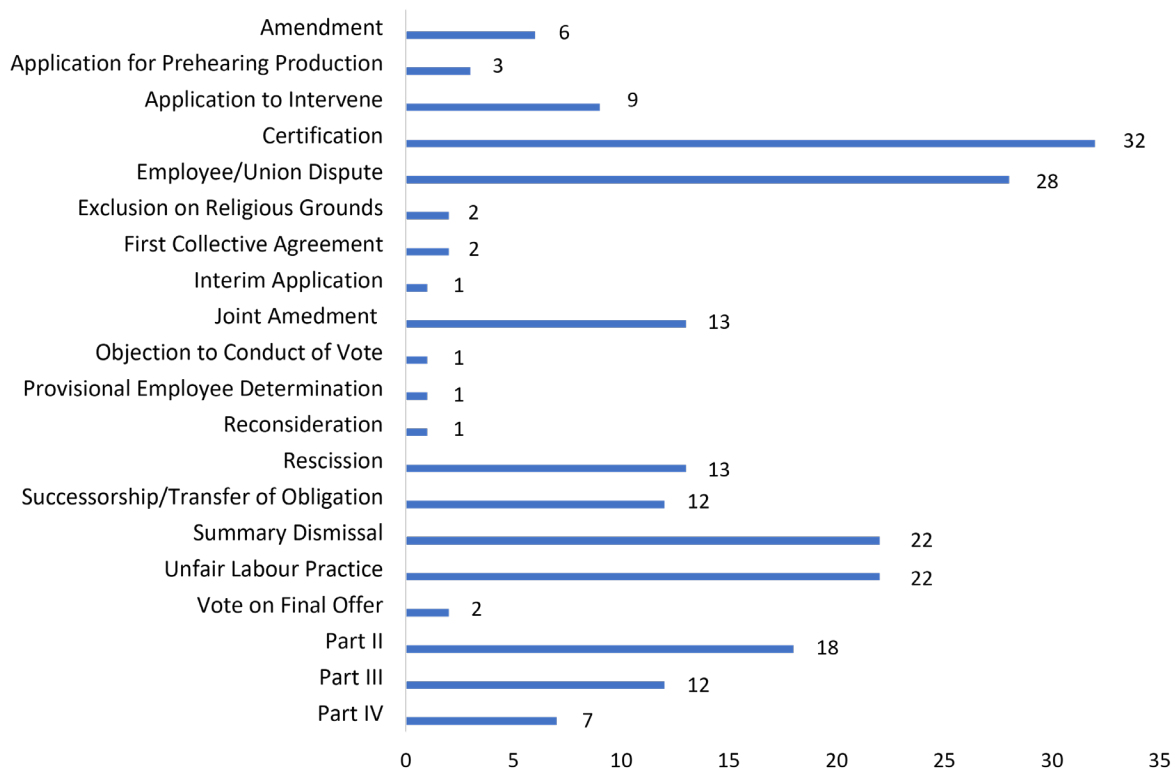

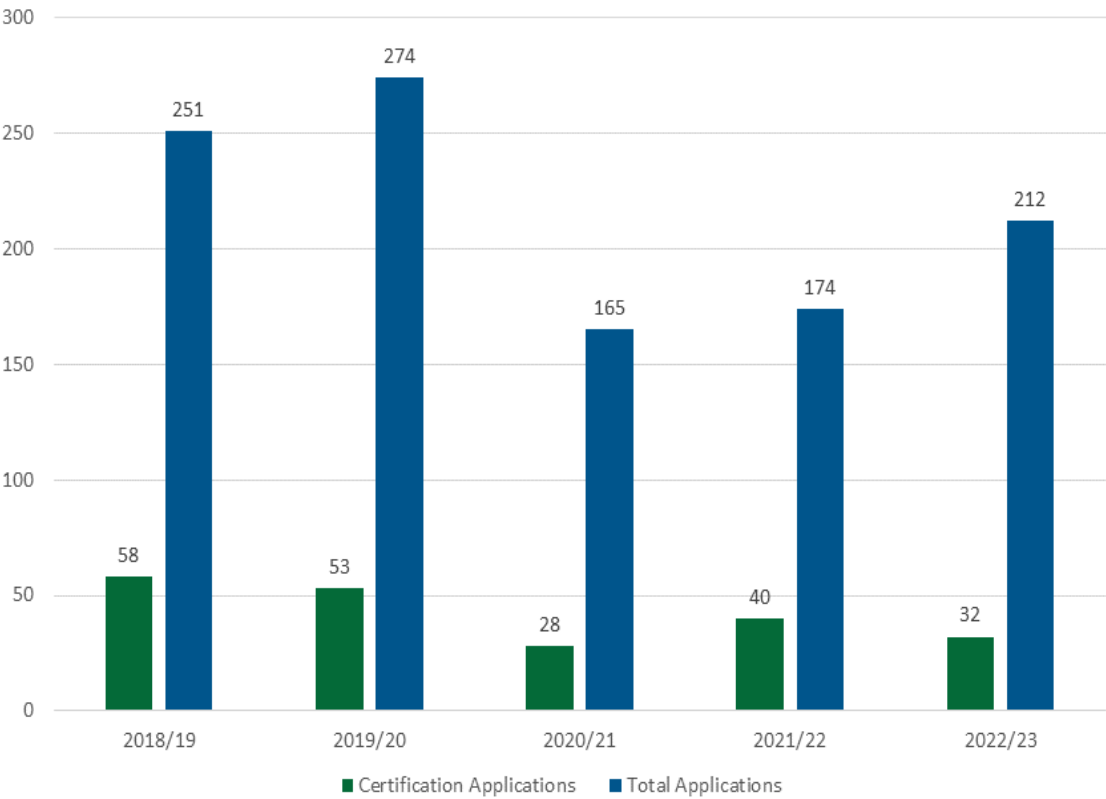
