Labour Relations Board

The Labour Relations Board was created in 1944 with passage of *The Trade Union Act*. Although this Act was often amended, and, in 2014, replaced by *The Saskatchewan Employment Act* (Act), the basic concept of the Board has not changed. The Board is an independent, quasi-judicial tribunal charged with the responsibility of adjudicating disputes that arise under the Act. It does this principally through public hearings and written decisions. The Board's decisions are final and binding on the parties. There is no appeal from decisions pursuant to Part VI and review by the courts is strictly limited.

The Act provides for a Board composed of a chairperson and up to two vice-chairpersons and an unspecified number of other members. All members of the Board, including the chairperson and vice-chairperson(s), are appointed by the Lieutenant Governor in Council. The chairperson and vice-chairperson(s) are full-time members of the Board. The remaining members are appointed and paid on a per diem basis when their services are required.

The Board is a representational one. This means that all members of the Board, with the exception of the chairperson and vice-chairperson(s), are representatives of organized employees or employers. The chairperson and vice-chairperson(s) are neutral and are lawyers. The Board reports to the minister of Labour Relations and Workplace Safety. The minister is obligated by the Act to provide the Board with any technical, clerical and administrative assistance that the Board reasonably requires. The Board operates independently from the government, its ministries and agencies.

The Board's offices and staff are located at 1600 - 1920 Broad Street, Regina. The Board also maintains a hearing room in Saskatoon. The staff of the Board is composed of the board registrar, secretary to the chairperson, board officer, board clerk and an administrative support position. The chairperson is the executive officer of the Board. An organizational chart of the Board is contained in Appendix A: Saskatchewan Labour Relations Board Organizational Chart.

Kyle McCreary – Chairperson

Kyle McCreary was appointed as chairperson of the Saskatchewan Labour Relations Board on May 7, 2024. Mr. McCreary received his Juris Doctor with distinction from the University of Saskatchewan and holds a Bachelor of Arts in Political Science with high honours from Carleton University. Prior to his appointment to the Board, he worked in private practice and as a Crown Counsel, most recently with the Civil Law Branch of the Ministry of Justice and Attorney General for Saskatchewan. At the time of his appointment, he was the director of litigation.



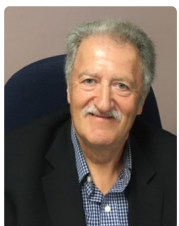
Carol Kraft – Vice-Chairperson

Carol Kraft brings extensive legal expertise to her role as vice chairperson, with a career spanning litigation, labour relations, and corporate counsel. Prior to her appointment, she served as Corporate Counsel at SaskTel and held senior legal roles at The Co-operators, including vice president and general counsel. Her public-sector experience includes positions with the Saskatchewan Ministry of Justice and Saskatchewan Government Insurance, where she led complex litigation and contributed to policy development. Hugh Wagner

Hugh Wagner retired as the general secretary of the Grain and General Services Union (ILWU-Canada) on March 24, 2023 after completing 48 years of service with the union. Mr. Wagner holds a Bachelor of Arts (Honours) Degree in Political Science from the Regina Campus of the University of Saskatchewan. Subsequent to joining the GSU, Mr. Wagner completed his thesis and obtained a Masters Degree in Political Science from the University of Regina. In addition to his duties with the Grain and General Services Union, Mr. Wagner served the union and the labour movement in a wide variety of forums, committees and consultative bodies. Mr. Wagner has served as labour member of the Saskatchewan Labour Relations Board since 1995.



Maurice Werezak

Maurice Werezak was appointed to the board in 2001 as a member representing employees. Mr. Werezak is a past vice-president of the Saskatchewan Federation of Labour and is president of United Food and Commercial Workers, Local 248-P. Mr. Werezak is a labour representative on the Employment Insurance Appeal Committee and was employed at Mitchell's Gourmet Foods. He is now retired.

Linda Dennis has retired from a labour relations practice primarily in British Columbia. She has been active in the emergency services, education, transportation, film production, health care, social services, municipal, trades and construction sectors. Chris Boychuk was appointed to the Board in 2024 as a member representing employers. He obtained a Bachelor of Science Degree, with distinction in 1982 and a Bachelor of Laws in 1986, each from the University of Saskatchewan. He was admitted to the Law Society of Saskatchewan in 1987 and has practised law in Saskatchewan since, primarily in the area of civil litigation with an emphasis in health, construction and employment law.



Lori Sali

Lori Sali was appointed to the Board in 2022 as a member representing employees. Ms. Sali was the business manager of the Labourers Local 180, she was elected in 2001, she stepped down in 2019 and is now semi-retired. She sits on three trust fund boards for the labourers and the Board of Directors for Golden Opportunities.

Allan Parenteau was appointed to the board in 2013 as a member representing employers. Mr. Parenteau is retired from the public sector where he worked for 41 years with the Government of Saskatchewan and the Saskatchewan Association of Health Organizations. 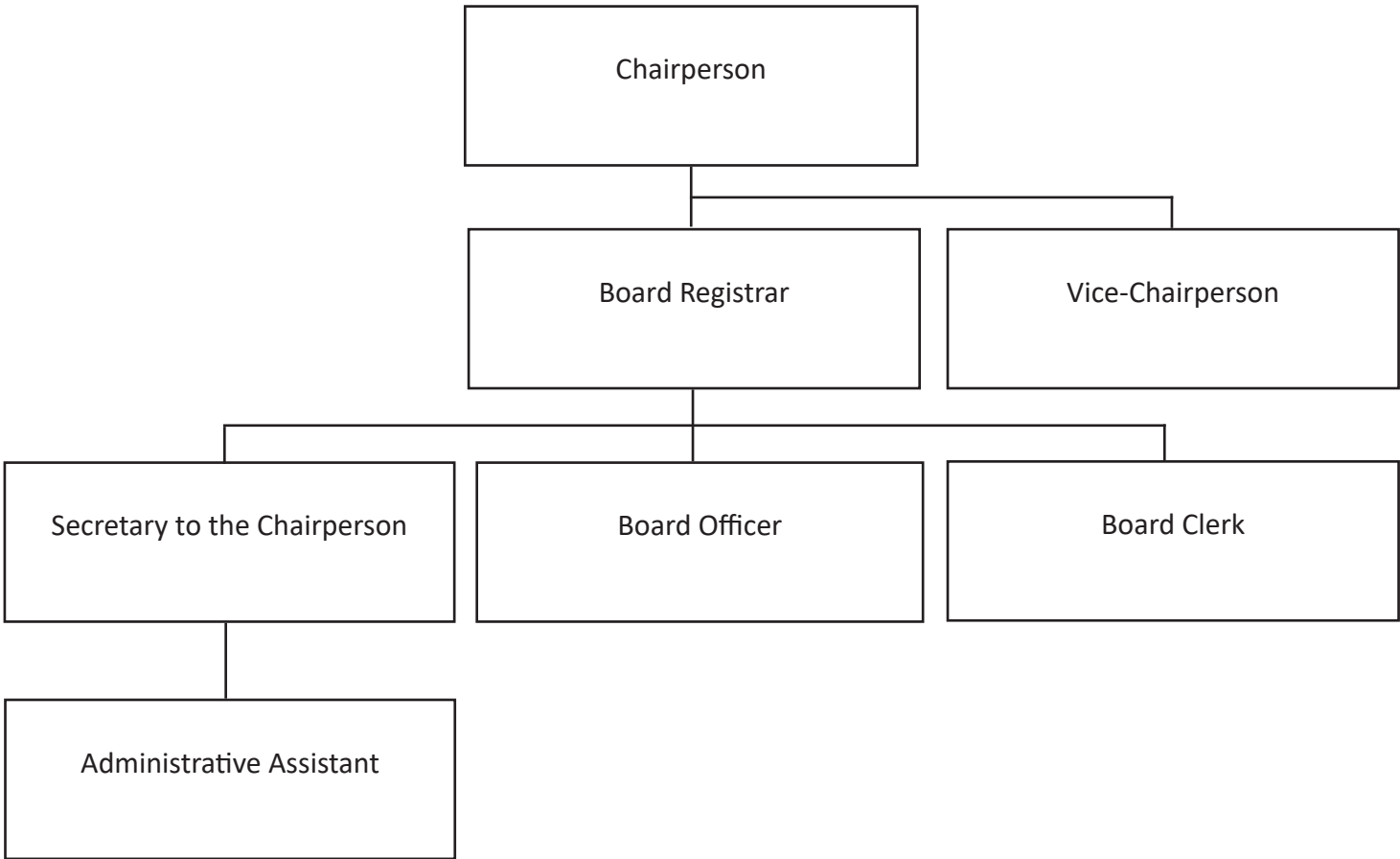

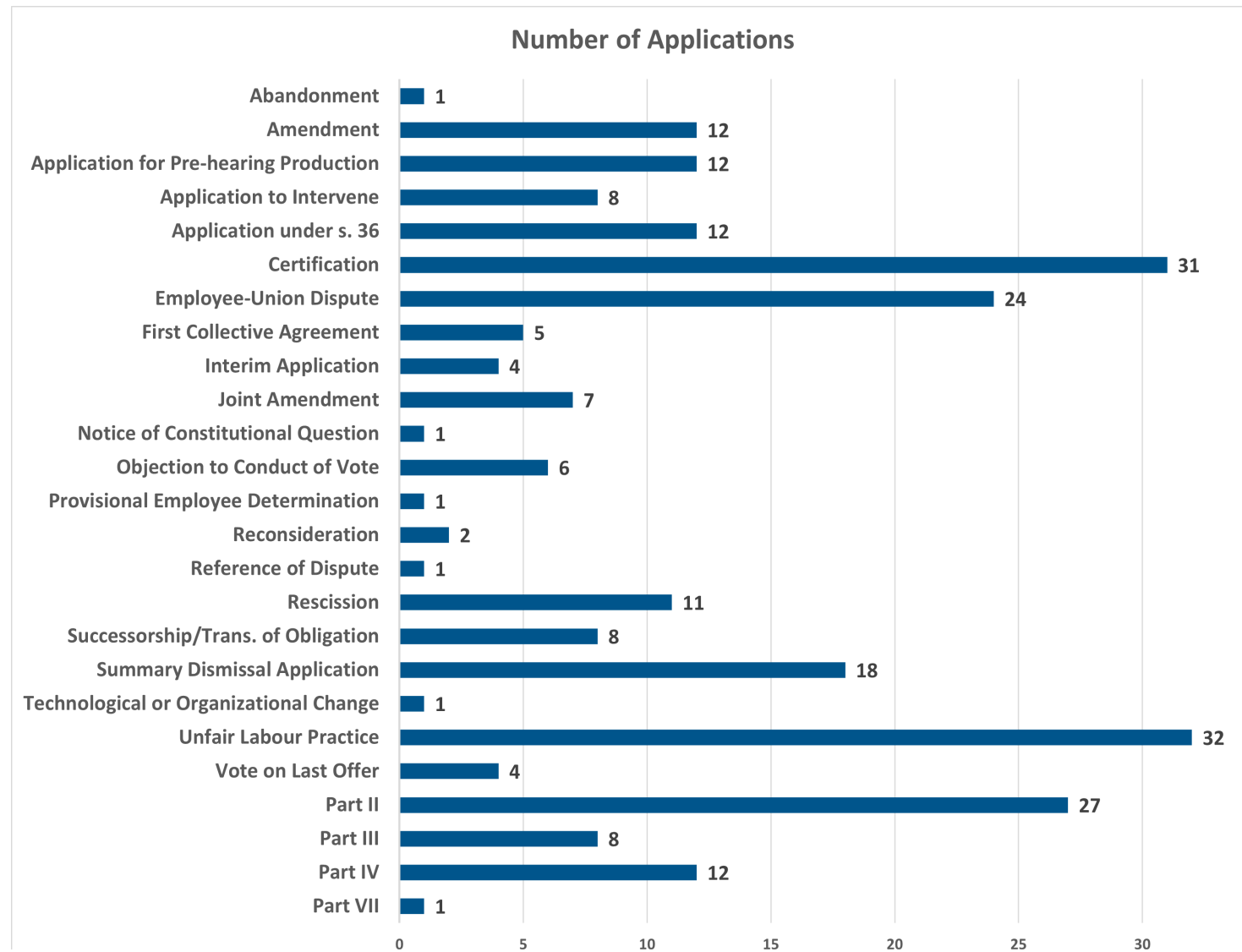

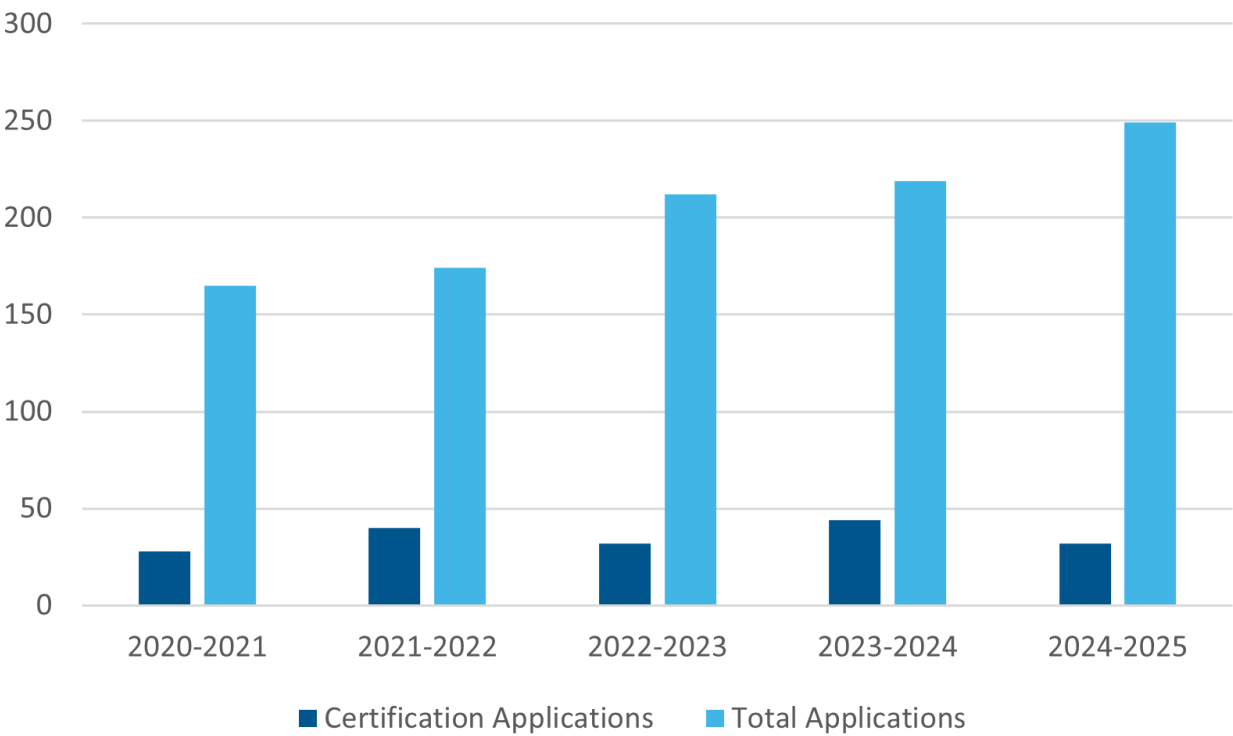
